Gas Exploration Task Force visits Barnett Shale

Ten members of the Lycoming County Community Gas Exploration Task Force recently visited their counterpart in Tarrant County, Texas, to share first-hand the experiences and lessons learned from gas exploration of the Barnett Shale.

In mid-May, the Board of Commissioners for the County of Lycoming and the Williamsport/Lycoming Chamber of Commerce partnered to establish a Community Gas Exploration Task Force. Its mission is to identify key issues, research facts and information, and review and propose public policy regarding the positive, economic impact of gas exploration of the Marcellus Shale in Lycoming County (see attachment 1). The 15-member Task Force has been meeting weekly.

During the period July-8-11, ten members of the Task Force traveled to Tarrant County, Texas, for meetings arranged by Tarrant County Economic Development Coordinator, Lisa McMillan (see attachment 2). The Lycoming County contingent was joined by Mr. Joseph McGowan, an assistant attorney general for the Commonwealth of Pennsylvania.

"The visit to Tarrant County to meet with and hear from those who have experienced the economic opportunities and challenges brought about by gas exploration of the Barnett Shale was extremely valuable," said Commissioner Rebecca Burke, the Task Force Chairperson. "We obtained valuable insights and approaches as Lycoming County seeks to inform our citizens and businesses regarding gas exploration in the Marcellus Shale here at home."
