1.0 OPERATIONS

- <u>1.1 CONVENE COMMISSIONERS MEETING.</u> Mr. Mussare convened the Commissioners Meeting 2:02 p.m.
- 1.2 ELECT CHAIRMAN OF THE BOARD. A motion by Mr. Mussare and seconded by Mr. Mirabito and passed (3-0), elected Jack McKernan to serve as chairman.
- 1.3 ELECT VICE CHAIRMAN AND SECRETARY OF THE BOARD. A motion by Mr. McKernan and seconded by Mr. Mirabito and passed (3-0), elected Tony Mussare to serve as vice chairman and Rick Mirabito to serve as secretary
