## 1.0 OPERATIONS

1.1 CONVENE COMMISSIONERS MEETING. The meeting was convened at 10:00 a.m.

Bids were opened for Consumable Energy Products (2 bidders).

## 2.0 ACTION ITEMS

- 2.1 APPROVE CASH REQUIREMENTS REPORT. A motion by Mr. Mirabito and seconded by Mr. McKernan and passed (2-0), approved accounts payable cash requirement report through December 7, 2016, for payment on November 30, 2016.
- <u>6.0 COMMISSIONER COMMENT</u>. The floor was opened to commissioner comment and the following were received:
  - Mr. Mirabito commented on the proposed 2017 budget and the town hall meetings that were held. He said the county is still at a deficit. He proposed to eliminate GEO and 20 positions through attrition as well as to use the hotel tax differently to reduce the deficit. If this was done he would be for a .5 mil increase. He wants a truly balanced budget.
  - Mr. Mussare said that certain policies and programs were implemented to address ongoing issues in a snapshot of time. The GEO program was part of a solution, to help reduce recidivism.
  - It has taken a couple of years to understand who fits into this program.

- Mr. Mirabito said we need to learn from this. Doing away with the program doesn't mean it was wrong at that time.
- Mr. Mussare said that we need to reduce the size of Lycoming County Government by selling unused assets (buildings).
- **7.0 PUBLIC COMMENT**. The floor was opened to public comment and the following were received:
  - Larry Stout suggested that county employers should be more receptive to hiring ex-convicts. "We the public" should be more owning of our problems.
  - Mr. Mirabito said that the re-entry coordinator position attempts to do this.
  - Matt McDermott suggested that many employers like to use our prerelease center clients as they are insured to be at the job on time and sober.
- **8.0 NEXT REGULARLY SCHEDULED MEETING.** Mr. Mussare announced the next regularly scheduled meeting to be held Thursday, November 6, 2016.
