1.0 OPERATIONS

1.1 CONVENE COMMISSIONERS MEETING. The meeting was convened at 10:00 a.m.

2.0 ACTION ITEMS

- 2.1 APPROVE CHANGE ORDER WITH INSINGER EXCAVATING. A motion by Mr. Mussare and seconded by Mr. Mirabito and passed (3-0), approved change order 2 with Insinger Excavating for the Emergency Watershed Protection project.

Mr. Lauer asked the Commissioners what their stance was on medicinal and recreational marijuana.

Mr. Mussare said there is proof that medical marijuana is effective, and it is legal here. He has concerns with regard to recreational marijuana as related to budget. He said decriminalizing it can help fund other programs. But this is not up to him.

Mr. Mirabito agreed about medical marijuana. He said there is a difference between legalization vs. decriminalization. This needs to be addressed at the federal level. His concerns are that marijuana today is stronger/more potent than it was 30 years ago.
