1.0 OPERATIONS

<u>1.1 CONVENE COMMISSIONERS MEETING.</u> The meeting was convened at 10:01 a.m.

2.0 ACTION ITEMS

- 2.1 APPROVE CASH REQUIREMENTS REPORT. A motion by Mr. Mirabito and seconded by Mr. Mussare and passed (3-0), approved accounts payable cash requirement report through August 23, 2017, for payment on August 16, 2017, in the amount of \$2,062,063.29.
- 2.2 NOTIFY VENDOR ADDITIONAL DUE DILIGENCE REQUIRED. A motion by Mr. Mirabito and seconded by Mr. Mussare and passed (2-1), approved notification of the vendor [GEO Re-Entry Services, LLC] that additional due diligence is needed with regard to the \$5/person/day contract amendment. There is no signed agreement and a vote will be taken as soon as possible.
- The following discussion occurred prior to the vote in regard to the request for the Commissioners to consider amendment #3 to a professional services agreement with GEO Reentry Services, LLC (GEO):
- Mr. Mirabito said that he would want to see the contract between GEO and the state and instead offer a partnership with the state instead of being offered \$5/person/day. He is also concerned with approval of this amendment as it may oversaturate the community.

August 15, 2017

- Mr. Mussare agreed with wanting to see the contract between GEO and the state. But he added that money we (the county) gets is a benefit. He asked for the term of the agreement to be clarified with an ending date (12/31/17).
- Mr. Mirabito made a motion to tell GEO to tell the State that they cannot take referrals until the County sees the contract between GEO and the state and formally votes on a contract amendment between the County and GEO. This motion died for lack of a second.
- Solicitor Smith clarified that this is a technical wrong [operating without a contract approved in a public meeting]. This can be fixed by doing our due diligence and ratifying a contract.
- Mr. Mussare said that he wants to make calls and follow up on this today.
- Mr. Mirabito emphasized that he wants a copy of the contract between GEO and the state.
- **<u>6.0 COMMISSIONER COMMENT</u>**. The floor was opened to commissioner comment and the following were received:
 - Mr. McKernan explained his dissenting vote above. He said that on July 14 a fairly extensive meeting was held with regard to the GEO discussion. He recalled providing a 'go-ahead' with the contract stipulating an end date of December 31, 2017. He felt there was no problem moving forward with a vote to follow in a public meeting to tie up loose ends.
 - Mr. Mirabito said that this needs to be done in a public meeting. He suggested to Mr. McKernan that it may be due to the fact that he (Mr. McKernan) is new to government.
 - Mr. Mussare commented on the program that aired on ESPN with regard to Little League Baseball and World Series.
- **<u>7.0 PUBLIC COMMENT</u>**. The floor was opened to public comment and the following were received:

Larry Stout from Montgomery asked that the Commissioners comment on personnel actions if a person has done something extraordinary to receive a promotion.

- **8.0 NEXT REGULARLY SCHEDULED MEETING.** Mr. McKernan announced the next regularly scheduled meeting to be held Thursday, August 17, 2017.
