For the past 6 months we have been addressing concerns with the Natural Gas Industry. Privately, we have supplied information and requested answers. We have pointed out how Mountain Meadow Lodge (Formerly Frozen Run Hunting Club) has mislead the community of Ralston. It is now Profit over Public Safety.

Alta Resources (Pat Bowers) waited until Christmas to excuse all concerns stating, "We have done our due diligence." Why was the fracking expedited before infrastructure was completed? Will we see mistakes and failures as witnessed at the Tioga County, Union Township Yaggie pad. The same at the Lycoming County, McNett Township Sheppard pad. Each impacting the Lycoming Creek water shed. Frozen Run and Red Run streams are already impaired by acid deep mine drainage. Our watershed is in GRAVE danger and an Environmental Disaster may result. Slacks Run and Cascade are already fracking. Rock Run and Pleasant Stream are next.

A legal injunction against Alta Resources to prevent fracking until a pipeline is completed to Pads A&D may be needed. Are we seeing a Back Door approach?
