1.0 OPERATIONS

- 1.1 CONVENE COMMISSIONERS MEETING. Mr. McKernan convened the Commissioners Meeting 10:05 a.m.
- 1.2 APPROVE THE MINUTES OF THE PREVIOUS MEETINGS. A motion by Mr. Mussare and seconded by Mr. Mirabito and passed (3-0), approved the minutes of the previous meeting as they are recorded.

Solicitor Smith – according to Robert's Rules of Order minutes are a record of what was done, not what was said. Minutes are to include;

- the names of participants,
- agenda items,
- calendar or due dates,
- actions or tasks,
- the main points
- decisions made by the participants
- Record what is the most important points
- Future decisions
- Documents: images, attached files

Commissioners may add attachments to the minutes as they deem appropriate.

Mr. Mirabito – Has concerns regarding the minutes. Historically, he also understands that previous boards also found the recording of minutes woefully inadequate when trying to understand prior thinking of leaders and their decisions.

- 1.3 RECEIVE PUBLIC COMMENTS (AGENDA ITEMS ONLY). Mr. McKernan opened the floor to public comment on agenda items only, and none were received. See Attached.
- Deputy Chief Scott Metzger In recognition of his retirement from serving Lycoming County for 32 years, Mr. Metzger read a statement. In the statement, he acknowledge that he would miss his Adult Probation Office family and his co-workers in the Sheriff's office and prison. He said he could not say enough good things about the people he worked with over the years. His job revolved around two goals: keep people safe and help individuals who had committed crimes turn their lives around. "My No.1 job was to serve the public. We're peace officers and with that comes great responsibility.
- Adult Probation Chief Ed McCoy Stated Metzger was ahead of his time by implementing cognitive programming in the County; helped coordinate the county- based probation and parole model for domestic violence supervision strategies, which has been implemented statewide. Metzger also helped developed the curriculum for parole officer training statewide. Also very involved in his Montoursville Community, he has served on the advisory boards for Big Brothers/Big Sisters and YWCA/Wise Options.
- Deputy Chief Scott Metzger gave appreciation to his parents for instilling in him the values of hard work, family, god and country. He finished with a prayer, from the Late President George H. W. Bush, "There is but one use of power and it is to serve our people."
- Commissioners and Sheriff Mark Lusk gave their appreciation for his service and leadership on behalf of Lycoming County, its citizens and employees.

7.0 PUBLIC COMMENT. Mr. McKernan opened the floor to public comments and the following were received:

Many Lycoming County citizens spoke on behalf of Linda Sosniak and having her appointed to the Planning Commission board. These are a synopsis of the

comments. There is a belief that it was a sexist decision to push aside a well-qualified woman for the board appointment. Requests were made to have the Commissioners rescind their decision. There were hopes the Commissioners would consider doing the right thing. People questioned the process of appointing people to the boards and requested more transparency. The citizens sited an underlying problem of institutional racism and are attempting to eliminate it and bring in more diversity to board appointments. Opportunities should be open to everyone, not only to people you know or look like you. Questions were asked as if, Linda Sosniak had been interviewed by the Commissioners. The citizens believed that Linda Sosniak deserved an apology for the process.
