Ms. Morningstar is looking to bring awareness to the public, how victims are blindsided through the kindness of these human traffickers who providing for innocent people and then kidnapped and taken to hotels and other states, where they are being used commercially for sex, turned into sex slaves. Mr. McKernan asked if there is a specific demographic that is susceptible. Ms. Morningstar stated people from all walks of life are being targeted. Teenagers are most susceptible due to their lack of awareness of the possibilities. Human traffickers groom people and lure them to different states.
