### 1.0 OPERATIONS

- 2.2 APPROVE AOPC (ADMINISTRATIVE OFFICE OF THE PA COURTS) PROBLEM SOLVING COURTS DISCRETIONARY GRANT. A motion by Mr. Mirabito and reluctantly seconded by Mr. Mussare and passed (3-0), approved. Mr. Mussare expressed his concern for the billions and billions of dollars going into the opioid epidemic. This has also turned into a money maker for some businesses, and other organizations. We have to be aware that people are taking advantage of a devastating situation. I am concerned about the senior citizens like Weldon, who worked hard his entire life and brings home \$700-\$800 a month on SSD. - Jenn McConnell and Judge Butts expressed they share the same concerns for senior citizens. Ms. McConnell explained that these grants have very specific guidelines and tries to address a part of a huge transportation issue that our rural area experiences.
- Judge Butts –" If you give a man a fish, you feed him for a day. But if you teach him how to fish, you feed him for a lifetime." "This is a way of, whether its bicycles or exercise or education, it's a way to alleviate poverty by creating self-sufficiency.

  Everyone agreed that funding is needed to address the many concerns facing senior citizens right now.
