### **1.0 OPERATIONS**

- <u>1.1 CONVENE COMMISSIONERS MEETING.</u> Mr. McKernan convened the Commissioners Meeting 10:02 a.m.
- <u>1.2 APPROVE THE MINUTES OF THE PREVIOUS MEETINGS.</u> A motion by Mr. Mussare and seconded by Mr. Mirabito and passed (3-0), approved the minutes of the previous meeting as they are recorded.
- <u>1.3 RECEIVE PUBLIC COMMENTS (AGENDA ITEMS ONLY).</u> Mr. McKernan opened the floor to public comment on agenda items only, and none were received.

#### 2.0 ACTION ITEMS

2.1 APPROVE ACCOUNTS PAYABLE CASH REQUIREMENT REPORT. A motion by Mr. Mussare and seconded by Mr. Mirabito and passed (3-0), approved through June 4, 2019, for payment in the amount of \$892,277.23.

<u>2.2 APPROVE PERSONNEL ACTIONS:</u> A motion by Mr. Mirabito and seconded by Mr. Mussare and passed (3-0), approved:

Veterans Affairs – Natalie S. Steppe – as full time new position/promotion Veterans Affairs Assistant- Pay grade 7 - \$19.09 per hour effective 6/2/19. Veterans Affairs – William M. McMunn – as full time replacement Veterans Affairs Assistant – Pay grade 6 - \$16.59 per hour effective 6/10/19.

- 2.3 APPROVE LEASE EXTENSION WITH HISTORIC FRANKLIN SCHOOL <u>PROPERTIES LLC.</u> A motion by Mr. Mirabito and seconded by Mr. Mussare and passed (3-0), approve an additional 24 months at the monthly lease amount of \$1922.09.
- 2.4 APPROVE AGENCY SERVICE AGREEMENT WITH PAYGOV.US.LLC. A motion by Mr. Mussare and seconded by Mr. Mirabito and passed (3-0) approve a payment processing system for Government agencies-Prothonotary office.
- <u>2.5 APPROVE PALMETTO POSTING.</u> A motion by Mr. Mussare and seconded by Mr. Mirabito and passed (3-0), approved for posting of Real Estate Tax Sale notices.
- 2.6 APPROVE FY2019-2024 MARCOS/PHILIPS COPIER LEASE. A motion by Mr. Mirabito and seconded by Mr. Mussare and passed (3-0), approved the five year lease to save the county an average of \$64,000 a year.
- 2.7 APPROVE EQUIPMENT RENTAL AGREEMENT FOR CRANE SERVICE WITH <u>WILLIAMSPORT CRANE AND RIGGING, INC.</u> A motion by Mr. Mussare and seconded by Mr. Mirabito and passed (3-0), approved.
- 2.8 APPROVE PROFESSIONAL SERVICE AGREEMENT WITH BARTON LOGUIDICE. A motion by Mr. Mirabito and seconded by Mr. Mussare and passed (3-0), approved for engineering services with no minimum.
- 2.9 AWARD PURCHASE AGREEMENT TO ORCHARD PUMP & SUPPY COMPANY, INC. A motion by Mr. Mirabito and seconded by Mr. Mussare and passed (3-0), approved for the purchase of 1- New Marlow Pump in the amount of \$11,780.00.
- 2.10 APPROVE CONTRACT WITH CLEAR BALLOT. A motion by Mr. Mirabito and seconded by Mr. McKernan and passed (2-1), approved to purchase the Clear Vote voting system in the amount of \$1,007,896.00. Mr. Mussare casting the no vote.
- In discussion with the Director of Voter Services, Forrest Lehman, Clear Vote is the best fit for the needs of Lycoming County and all its stakeholders. The size of the system reduces the logistic costs of transporting the system to the 86 precincts. The volunteers will be able to continue fitting the machine into their cars. This system is in compliance to the State's requirement to provide paper documentation of the vote cast, a voter verifiable paper trail. Mr. Lehman stated that the machines are not able to determine, if the vote cast is a legal one. That is deemed a separate issue and the responsibility of voter registration. The new system will be in place for the upcoming fall election. It is important to remain on this timeline, so that the system has the ability to work out any issues prior to the 2020

Presidential election. The state moved up the deadline for the updated voter systems.

- Mr. Mirabito appreciated the time and efforts Mr. Lehman invested in the research and evaluation of the new voter system.
- Mr.Mussare is very upset that the State is mandating the upgrades of the voting systems, to me to verify what the intent of the voter was. off of the touchscreen, and to have the paper verification does not seem to be the biggest problem that faces America today, as our borders are opened up and we are being inundated with illegal people. Here in Lycoming County we had one person voting for several years that was not an American citizen. Voting as an American is our most precious right. Only the votes of the United States citizens should count. How does that happen? All they have to do is check the box that they are Americans and there is no verification required. When we asked for VoterID, what the hell happened? If it can happen here in Lycoming County, imagine it can happen all across this country. Does the machine, this process protect us from having people check that box.
- Mr. Lehman You are correct, the issue you are raising is a question that a new voting system is not able to address. That is a voter registration issue, that has to do with whether is eligible to vote or not. That issue is already addressed prior to a citizen voting on the touchscreen.
- It was discussed that the verifiable paper trail will help address some issues to prevent an election for being invalidated.

# 2.11 APPROVE PURCHASE AGREEMENT WITH PA CHIEFS OF

POLICE/DATAWORKS. A motion by Mr. Mussare and seconded by Mr. Mirabito and passed (2-1), approved to provide livescan fingerprint stations and digital arrest phot equipment and maintenance in the amount of \$34,000. Following the directive by Governor Wolf to upgrade systems to Windows 10 for Central Processing and the Williamsport Police Department.

2.12 <u>APPROVE ANNUAL RENEWAL</u> OF LICENSING FOR FULL COURT <u>SOFTWARE.</u> A motion by Mr. Mirabito and seconded by Mr. Mussare and passed (3-0), approved in the amount of \$11,825.00 budgeted IS item for the Prothonotary's office.
