1.0 OPERATIONS

- 1.1 CONVENE COMMISSIONERS MEETING. Mr. McKernan convened the Commissioners Meeting 10:06 a.m.

Public Hearing for the proposed issuance by the Geisinger Authority of its health system revenue bonds. (TEFRA Hearing)

Mr. Fitzgerald - We are asking your approval of two resolutions to help finance our health care services, facilities and software. We came to provide support for the resolutions. We are looking for as much as one billion dollars. Most of the money is to assist with refinancing, and up to \$200 million dollars could be considered new money and be spent on buildings, facilities in the area. The most important thing to know is the County and its taxpayers are not obligated for the repayment on these bonds. The intended majority use is for refinancing and a portion of the bonds will be used for valid charitable works that benefit the County and residents. We have offered as a system over \$78 million for indigent care, \$642 million for government programs. Geisinger Health Systems is wholly responsible for the bonds. Last year, we saw approximately 36,000 Lycoming County residents for some level of medical care last year with over 300,000 outpatient visits-2,600 inpatient cases. System wide we have provided a lot of economic benefit, globally, approximate \$14 Billion dollars' worth. Jersey Shore Hospital recently joined the family; we have created a local economic impact of \$40 million dollars by our spending, salaries that we pay. My colleagues and I are here to answer any questions you may have.

- Mr. Mirabito I noticed that the areas that are serviced by the bonds include Marworth, and other places. Are you holding hearings in all of these places?
- Mr. Fitzgerald Yes, That is correct according to Tax Law and Pennsylvania Statutes, we are required to come before the governing bodies of the areas and ask their permission.
- Mr. McKernan opened the floor to comment for the TEFRA

 Hearing and none were received. He also inquired, "Is there anyone who would
 like to speak in opposition to this bond?" There were no comments, nor was
 there any one to speak in opposition to the resolution.
- Mr. Mirabito I would like to mention that in addition to providing health care, the economic impact of health care facilities is extremely important to rural communities like ours, 47 rural Counties in the state, health care systems are the economic driver in these counties as far as jobs. We appreciate you being here and look forward to working with you.
- Mr. Mussare I sit on the CTE Board and we discussed about Health Care over the next decade and there is expectation that health care needs will grow about 40%. When you start to think about that number, are we prepared for the care

of our aging seniors? As a Commissioner, I appreciate you investing in our community as well and the quality of care that you give our residents.

Geisinger representatives expressed their concern for the increased needs of aging seniors and are also preparing for the increased health care needs.

Mr. Mirabito - We hear a rumor that you are building a hospital. We are excited to see what your plans are.

Mr. Fitzgerald – That is true. We have recently announced it and are excited.
