Statement By the Lycoming County Commissioners

January 11, 2024

Last Thursday Senator Casey visited Lycoming County to discuss the levee and federal funding associated with its repair and upgrades. The Commission was insession at the time of his visit and therefore the commissioners were unable to attend. So, because we weren't there to comment, we would like to make a statement regarding the importance of completing the levee project for the safety and economic health of the County.

First, we would like to thank Senator Casey for visiting the levee and for his commitment to work with the County and the City to provide continued funding to ultimately get the levee accredited and certified.

We also want to thank former Congressman Fred Keller who initially included \$8 million through the House's Community Project Funding process (otherwise known as an earmark) in the fiscal year 2023 Appropriations bill that funds Homeland Security. As many of you know, the Congressman had a history of opposing earmarking, but in the case of the levee, a safety concern, he agreed to use the earmark process for the levee. It's also important to mention that he used his entire earmark allocation for this levee project. Congressman Keller loved the people of Lycoming County. He made it known that they deserve this project and he was going to utilize all his resources to get it through.

Finally, I'd like to thank the US Army Corps of Engineers for its work thus far in assisting the County and the City in determining exactly what parts of the levee are priorities. As many know, we've had some delays and starts and stops with the Army Corps' process, which has been frustrating, but the time is now to move this process forward and to its conclusion -- which can only be done with the Anny Corps leading it and frequently coordinating with FEMA and PEMA Also, our Planning Department has spent countless

hours in this process. Many thanks to them

The greater Williamsport levee is the source that protects some \$4 billion in community assets - including residences, businesses, schools, medical facilities, etc. The County has worked long and hard to take the necessary steps regionally and in Washington to ensure the levee is the number one community priority. Its repair and upgrade will be the source of protection for our community resulting in economic vitality for the region for years to come.

The County will continue to work with our partners at the federal, state, and local levels to ensure this work gets done. The County is committed to this project.
