Discussion:

Mr. Mussare – When the law clerk passes her bar exam? What will her pay be, will that automatically increase? At that time, how many attorney's will there be?

Mrs. Grieco – Yes, the position would increase to pay grade 11. There will only be one attorney in that department once she passes the bar.

Mr. McKernan – There is no attorney, but there is someone who has the appropriate credentials.

Mr. Mirabito – The reason Domestic Relations brought this to us, because under Federal Guidelines, they cannot have a non-attorney going into court to present a case on behalf of Domestic Relations. In order, for us to get the money from the Federal Government that we do, we must be in compliance with Federal regulations. We have to have an attorney presenting the case.

Mr. Mussare – We currently do not have an attorney in Domestic Relations office?

We do not have an attorney performing attorney duties in domestic relations. The Deputy is an attorney, but she is not performing the duties.

Mr. McDermott – Technically, the Deputy has a JD, but she is not acting as the attorney for Domestic Relations or nor is she performing attorney functions.

Mr. McKernan – We use an outside lawyer to perform the attorney duties for Domestic Relations. We will pick up the savings on that WE will qualify for more Federal monies,

Mr. Mirabito – This will help us be in compliance with the Federal Govt regulations. Technically, I am a lawyer, but I am not practicing law as a commissioner.

- Mr. Mussare How many attorneys will there be in Domestic Relations, once she passes her bar. You said, "One", that will not be true; there will be two attorneys in the Domestic Relations department. Are we currently not in compliance?
- Mr. McKernan and Mr. Mirabito Technically, no.
