

NOTICE TO BIDDERS

COUNTY OF LYCOMING, PENNSYLVANIA

SEALED BIDS will be received by the Controller of the County of Lycoming, at Suite 201, Executive Plaza, 330 Pine Street, Williamsport, PA 17701, until April 5, 2019 at 5:00 p.m. prevailing time. Bids will be opened at the regular meeting of the Lycoming County Commissioners at 10:00 a.m. prevailing time on April 9, 2019, for:

LYCOMING COUNTY LANDFILL FIELD 12 CONSTRUCTION

The project consists of the construction of a double synthetic lined landfill cell, Field 12, at the Lycoming County Landfill and related work including: earthwork including cut, fill and transport to borrow area for landfill area construction; installation of 66,450 square yards of earth subbase for liner; 66,450 square yards of double composite synthetic landfill liner and accessories; installation of 66,450 square yards of protective cover stone over liner; one new leachate pumping station; leachate and landfill gas piping within and adjacent to the new landfill cell; storm drainage construction including 12 inch temporary storm piping, and inlets; two anchor trench stormwater pumping stations; electrical and communications wiring for the leachate and anchor trench pumping stations; and miscellaneous related work described in the Bidding documents.

The Work is to be substantially completed for Owner's use within 450 calendar days from the date specified in the Notice to Proceed. Liquidated damages of \$2,000.00 per calendar day will be assessed after the date for Substantial Completion. Final completion of the Work shall be within 510 calendar days from the specified in the Notice to Proceed. Liquidated damages of \$1,000.00 per calendar day will be assessed after the date for Final Completion.

Bids shall be prepared and submitted in accordance with the Instructions to Bidders contained in the Bidding Documents.

Bidding Documents and supplementary documents may be **examined** at the Lycoming County Resource Management Services Landfill site, U.S. Route 15 approximately 12 miles south of Williamsport, PA and at the office of the Cummings & Smith, Inc., 214 Little Falls Road, Fairfield, NJ 07004.

Bidding Documents and supplementary documents may be **obtained** from the Issuing Office listed in the next paragraph, after March 13, 2019, upon payment of a non-refundable fee of \$250.00, payable to County of Lycoming.

Bidding Documents may be picked up at the Issuing Office address listed above, or will be shipped to prospective Bidders at Bidder's expense upon supply of shipping company account information.

Each Bid must be accompanied by:

1. Bid Security in the form of a surety company Bid Bond or certified check, drawn on a bank authorized to do business in the Commonwealth of Pennsylvania, payable to County of Lycoming in an amount of not less than ten percent (10%) of the total bid,
2. an agreement to become Surety, properly executed by a surety company authorized to do business in Pennsylvania, and
3. other documents as may be listed in the Instructions to Bidders and the Bid Form.

Bids shall be submitted to the Controller of the County of Lycoming at the location, and at or before the date and time indicated in the first paragraph of this Notice to Bidders.

Wages paid to employees of the successful bidder shall be subject to the requirements of the Pennsylvania Prevailing Wage Act.

No Bidder may withdraw his Bid within 60 days after the actual date of the opening of Bids.

A ***mandatory*** Pre-Bid Conference will be held on March 27, 2019, at 1:30 p.m. at the Lycoming County Landfill Administration Building located at the site of the Work.

The County will not award a contract to anyone who cannot prove to satisfaction of the County that he has sufficient experience in this type of construction and is financially able and organized to successfully carry out the Work covered by the Bidding Documents in the required time. Each Bid shall be accompanied by completed questionnaires relating to the Bidder's qualifications and financial status.

All Bidders shall be aware that the County is an agency subject to the Right to Know Law. Any documents submitted should be considered as subject of potential public disclosure once the bid is awarded. In addition, the County will post information regarding the successful bid on the County website.

The County reserves the right to reject any or all Bids, to waive any informality in Bids received, and to accept that Bid which in its judgment best serves the interest of the County.
