On 3/5/2012 LCRMS began placing select waste in the western most corner of the recently completed Field 11. Only select waste will be disposed in the new field until the first lift (8 feet) is completed across the entire field.

Earlier this year Lobar Construction began the 2-year project of constructing the new Leachate Tank. The 5.5 million gallon capacity is such that volume will never exceed 25% under normal storm conditions.

REMINDERS TO ALL HAULERS:

- Containers are to be turned only at the working face, NOT at the container storage area.
- All loads are to be completely covered (i.e. TARPED) during transportation to a disposal site. Tarps must remain tightly in place until delivery to the dumping pad.

Computer Disposal Ban Update:

In accord with The Covered Device Recycling Act (Act 108 of 2010) effective January 24, 2013, LCRMS would like to remind you that all computers (including laptops/notebooks) computer monitors, computer peripherals (keyboards, printers, mice, or other device sold for use with a computer that provides input or output from the computer), and televisions marketed and intended for use by consumers or small businesses are **banned from disposal in municipal waste landfills**.

Haulers, please start letting your customers know that as of January, 2013 these materials cannot be put with their regular trash. You can tell them (as stated above) that they will be able to deliver these materials to the LCRMS recycling center for proper handling by the end of April.

To encourage participation in this effort, DEP, Brady Township,

and the Lycoming County Commissioners have granted a **waiver of all disposal fees** for waste collected from registered events delivered to the landfill* during the designated time frame (4/21/12 - 5/7/12).

To qualify for the free disposal, a *Great American Cleanup PA! registration number* must be presented to the weighmaster upon arrival at the landfill.

Please note that disposal and processing fees are not waived for white goods and tires.
