#### RATES PAID FOR RECYCLABLE MATERIALS:

The renovations to the recycling facility are complete and the facility is processing single-stream material and **paying for it!** The rates paid for Single Stream and other recyclable materials will be dependent on market conditions and will be evaluated on a monthly basis. Please contact the recycling department at the beginning of each month for current rates.

#### **GUIDELINES FOR SINGLE-STREAM RECYCLING:**

- 1. Single Stream material will only be accepted at the recycling facility during the center's normal business hours: 7:00 AM-3:00 PM; Monday-Friday.
- 2. PLEASE NOTE: The recycling center is currently not open on Saturdays.
- 3. Loads of recyclables will be received at the Recycling Center scales.
- 4. When pulling on to the scales you will need to report to the weigh master:
  - A. The municipality of origin: township/borough/city and county
  - B. An estimate of the percentage residential versus commercial material in the load for each municipality
- 5. All material must be dry and loose—not in plastic bags. The use of wheeled totes or similar collection containers is encouraged. A list detailing what is and what is not accepted is available on our website.
- 6. LCRMS reserves the right to reject loads with excess contamination. Any rejected load will be charged the posted rate for Municipal Solid Waste.
