Congratulations to Ed March who has been named as the new Transfer Station operator. When you see Ed, his face may look familiar to you—he started his career at the transfer station as a transfer trailer driver. Please welcome Ed in this new role.

TRANSFER STATION CUSTOMERS:

Recently we've seen a lot of instances of trucks with liquid actively leaking onto the scales at the transfer station. Not only is this an odor nuisance for our customers and employees but it means that your truck is out of compliance with regulations regarding the transportation of waste.

The following Pennsylvania Environmental Protection regulations pertain to leaking waste transportation vehicles or containers:

285.213(a)(1)(iii): "Collection and transportation equipment shall be...constructed to prevent the potential for...leakage..."

285.213(c): "Equipment...shall be tested, inspected and maintained by the operator to ensure that there is no release or leakage of waste..."

Leaking from your waste transportation vehicles is a finable offense from both local law enforcement and the Department of Environmental Protection. Please assure that all trash hauling trucks comply with all regulations.

SINGLE STREAM RECYCLING UPDATE

The renovations to the recycling facility are nearing completion. This week the contractor will begin running the equipment with product to begin fine-tuning the operation.

Effective September 1st—we will be accepting single stream recycling at no charge!

This is first step in moving towards being able to pay for the single stream product. We will be evaluating material and product quality during the most, if not all, of the month of September.

Once we are offering payment for single stream material, pricing will be updated on a regular basis based on market conditions. Current pricing will be available on the LCRMS website on the recycling page. (The link to the Webpage is the top of this article)
