Sealed, Bids for the construction of the sewage force main from the proposed junction box near the Lycoming County Landfill entrance to the Gregg Township Allenwood equalization tank will be received by the Controller of the County of Lycoming, at Suite 201, Executive Plaza, 330 Pine Street, Williamsport, PA 17701, until **5:00 PM** local time on the **21**st **day of February 2020.** The Bids received will be publicly opened and read at the regular meeting of the Lycoming County Commissioners at 10:00 a.m. prevailing time of the **25th day of February 2020.** The Project consists of constructing an approximate 8,350 linear foot sewage force main from the Brady Township Southeast Plant to the Gregg Township Allenwood Equalization Tank to be referred to as the Brady-Gregg Sewage Force Main. Additionally, the project consists of constructing a 1,000 linear foot dual walled 6"/3"sewage force main from the Lycoming County Landfill pump house to the Gregg Township Allenwood Equalization Tank. The Brady Extension will start at a proposed junction box near the entrance to the landfill and terminate at a proposed manhole approximately 1,000 feet (south) of the junction box on the (east) side of US Route 15.

The Work is to be substantially completed for Owner's use within 240 calendar days from the date specified in the Notice to Proceed. Liquidated damages of \$2,000.00 per day will be assessed after the date for Substantial Completion. Final completion of the Work shall be within 300 calendar days from the date specified in the Notice to Proceed. Liquidated damages of \$1,000.00 per day will be assessed after the date for Final Completion.

Bids will be received for a single prime Contract. Bids shall be on a lump sum basis, as indicated in the Bid Form.

Bidding Documents and supplementary documents must be examined at the Lycoming County Resource Management Services Landfill site, U.S. Route 15 approximately 12 miles south of Williamsport, PA, and the offices of Barton & Loguidice, D.P.C., at 214 Little Falls Road, Fairfield, NJ 07004 and 3901 Hartzdale Drive, Suite 101, Camp Hill, Pennsylvania 17011.

Bidders requesting documents shipped via common carrier (FedEx) shall furnish an account number to be directly billed. Bidders will be responsible for providing a non-P.O. Box mailing address. The date that the Bidding Documents are transmitted by the Issuing Office will be considered the prospective Bidder's date of receipt of the Bidding Documents. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither Owner nor Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office.

Each Bid must be submitted on the prescribed Bid Form and accompanied by Bid security, as prescribed in the Instructions to Bidders.

The Successful Bidder will be required to furnish the additional bond(s) prescribed in the Bidding Documents.

In order to perform public work, the Successful Bidder and Subcontractors prior to contract award shall hold or obtain such license as required by State statutes, and Federal and local Laws and Regulations.

Wages paid to employees of the successful bidder shall be subject to the requirements of the Pennsylvania Prevailing Wage Act.

No Bidder may withdraw their Bid within 60 days after the actual date of the opening of Bids.

The County will not award a contract to anyone who cannot prove to the satisfaction of the County that they have sufficient experience in this type of construction and are financially able and organized to successfully carry out the Work covered by the Bidding Documents in the required time. Each Bid shall be accompanied by completed questionnaires relating to the Bidder's qualifications and financial status.
