  - A motion to nominate Ann Kilburn for Treasurer was made by Esther Cohick; seconded by Lynn Hartley.


## The officers elected are:Chair: Alice BairCo-Chair: Barb ThomasSecretary: Esther CohickTreasurer: Ann Kilburn


Barb Thomas made a motion to adjourn the meeting; seconded by Maggie Sockman.


It's just nice not having a regular, rigid work schedule, but instead a schedule filled with things you want to do. I did have



## ABBEY TALES

In May, Abbey started having difficulty standing up from a laying down position. I thought maybe she had just played too hard and her leg was tired. I watched her for about a week and she didn't seem to get any better. We went to her veterinarian, he examined her and he too thought that maybe she just strained her leg. He gave her a lyme disease test just to be sure she did not have it. That test was negative. He put her on Rimadyl, which is a non-steroidal anti-inflammatory drug. There was no noticeable change with the Rimadyl.

In June her veterinarian examined her again and x-rayed her hips thinking maybe she had hip dysplasia. He put her on Tramadol for pain and Previcox for pain and inflammation. Again, there was no noticeable change. In July she started limping very noticeably. We went back to her veterinarian, again. He put her on Prednisone (what an evil drug) and Doxycycline, which is antibiotic anti-infective drug. She was on Prednisone and Doxycyline for about a week. Let me tell you about her week on Prednisone! It was a very long week. She was just not herself, she was restless and it was like she was in her own private world and that was a far away place from the real world! She drank at least 2 gallons of water a day and what goes in must come out. She had to piddle all day AND all night.

After a week she was showing no signs of improvement so we decided to get a second opinion. We went to a different veterinarian and he examined her. He said he thought it was her knee. He x-rayed her knees he also did blood work since she was on Prednisone. After the x-rays he said that it was her knee and that she should stop taking the Prednisone (thank goodness) and Doxycycline. He referred her to the Northeast Veterinary Referral Hospital in Plains. At the hospital they have veterinary orthopedic surgeons.

On August 7, she went for her appointment to the hospital. While we were in the waiting room she made friends with every person and every dog that was in the waiting room. There was a black lab puppy there and she had a sore leg so

she wasn't allowed to play. Abbey couldn't stand not making friends with her so she laid down flat and slid across the waiting room (like a snake) to visit the puppy. Everyone in the waiting room burst out laughing at her. Someone commented that she never had so much fun in a waiting room!

The orthopedic veterinary surgeon examined her and looked at her x-rays. She was diagnosed with a torn cranial cruciate ligament. She was scheduled for surgery on August 18. She was not permitted to eat anything after 8:00PM the night before her surgery. I gave her a snack at 7:30 because I knew she would be a "Starvin' Marvin" in the morning. She is a big girl, 90 lbs., and she likes to eat. In the morning she kept going to her food bowl looking for her breakfast.

Her surgery went well and she was able to come home late that day. She had 6 staples in her leg. When they brought her out to go home she was shaved, had staples and was limping but she was still wagging her tail for everyone and happy. As for me I was not so happy, let's just say I was devastated when I saw her (even though I knew what to expect). Sometimes she would hobble around on 3 legs and other times she would limp on her sore leg. She was restricted to the house (she could only go outside to "go") and she could not jump. She had difficulty standing up because she could not put a lot of weight on her sore leg and going outside was challenging for her because she had to go up and down 3 steps. On Sept. 1, she went back to the hospital for a re-check and to have her staples removed. The doctor checked and manipulated her knee. When he moved her leg around she did not have any pain. He said that the good news is that her knee is good and the bad news is that she is still on running, exercising, and jumping restrictions.

She still limps but she is getting around much better. She actually wants to try to run now so I have to put her on a leash to take her outside. She probably wonders what's up with the leash because when she is at home I do not leash her. On Sept. 16, she went for another re-check. Her knee is good. She is still limping but the veterinarian said it will take awhile for her to get back to normal. She has to walk to build up the muscles (she has disuse muscle atrophy) in her leg since she has not been using that leg enough. She is allowed to go for 10 minute walks for a week, then she can go for 20 minute walks for a week after that she can walk for as long as she wants. She cannot run for another 2 weeks so she will have to go outside on a leash for 2 more weeks. She has had a tough summer but soon she will be able to play and run all she wants.

### <u>Pumpkin Dip</u>

- 4 c. confectioners sugar, sifted
- 2 (8 oz. each) pkg. cream cheese, softened
- 1 (30 oz.) can pumpkin pie filling mix
- 2 tsp. ground cinnamon
- 1 tsp. ground ginger

In a large mixing bowl, combine sugar and cream cheese, beating until well blended. Beat in remaining ingredients. Serve with gingersnaps, animal crackers, pretzels, graham crackers, fruit, etc. Makes about 7 cups of dip.

### <u>Meatballs</u>

- 2 lbs. hamburger
- 1 cup dry bread crumbs
- 1 cup grated cheese (good quality Romano or Parmesan or mixture of both)
- 2 eggs
- 1/2 cup milk
- 1/4 cup warm water
- 2 Tablespoons fresh chopped or snipped parsley
- 2 teaspoons minced fresh garlic
- 1 Tablespoon black pepper

Mix well and shape into the size of meatballs you like and brown in olive oil. Finish cooking in your favorite tomato sauce.
