Proclamation

National Breastfeeding Month

WHEREAS, human milk feeding is the biological norm for infant and young child feeding and a proven primary prevention strategy that builds a foundation for life-long health and wellness; and

WHEREAS, all major medical authorities recommend exclusive human milk feeding for the first six months of life, with continued human milk feeding after solid foods are introduced for up to 2 years and beyond; and

WHEREAS, protecting and supporting human milk feeding is essential to ensure critical food security, especially during natural disasters, and immunologic protection for our youngest citizens; and

WHEREAS, Lycoming County recognizes access to parent-friendly and breastfeeding-friendly workplaces and public spaces is a human right; and

WHEREAS, 8 out of 10 of newborns receive human milk at birth, low income families face the most significant barriers for continuation, resulting in only 3 out of 10 of these infants still receiving any human milk at 6 months; and

WHEREAS, there are substantial racial and ethnic disparities in access to culturally congruent lactation support resulting in lower initiation and continuation of chest/breastfeeding, which increases preventable diseases and health risks for parent and child; and

WHEREAS, National Breastfeeding Month in August provides an opportunity to identify and address racial inequities and barriers to human milk feeding within Lycoming County with recognition of World Breastfeeding Week, Native Breastfeeding Week, Asian-American Native Hawaiian Pacific Islander Breastfeeding Week, and Black Breastfeeding Week; and

WHEREAS, the consistent and well-documented health, economic, and environmental benefits of human milk feeding show that this is an investment that will continue to produce measurable dividends across the county and many times over for families, employers, and the government.

NOW, THEREFORE BE IT RESOLVED, that Lycoming County Commissioners, designate August 2022 as "Breastfeeding Month" and recognize the essential role of elected and appointed leadership, healthcare systems, non-healthcare support groups, correctional facilities, local businesses and organizations, and education systems in creating a Breastfeeding Family-Friendly Community.
