Mr. Mussare would like to advocate for seven residents from the Muncy area that repaired a private bridge at their own expense and are now being challenged by DEP.

Mr. Mirabito spoke to questions posed by an editorial comment in the Sun Gazette related to the Lycoming County Employee Health Center. He explained decision was made after reviewing several proposals, a tour of a local employee health center, multiple discussions for over a year by the Commissioners. The primary deciding factor was to improve overall employees' health, ease of access and reduce health care cost for them, as well as for the County. The calculated rate of savings will be roughly 150%, for every dollar that is spent it is equivalent to a saving \$1.50.
