1.0 OPERATIONS

- <u>1.1 CONVENE COMMISSIONERS MEETING.</u> Mr. McKernan convened the Commissioners Meeting 10:05 a.m.
- 1.2 APPROVE THE MINUTES OF THE PREVIOUS MEETINGS. A motion by Mr. Mirabito and seconded by Mr. Mussare and passed (3-0), approved the minutes of the previous meeting as they are recorded.
- 1.3 RECEIVE PUBLIC COMMENTS (AGENDA ITEMS ONLY). Mr. McKernan opened the floor to public comment on agenda items only, and none were received.

2.0 ACTION ITEMS

- 2.1 APPROVE CJAB GRANT APPLICATION. A motion by Mr. Mirabito and seconded by Mr. Mussare and passed (3-0), approved CJAB Technical Assistance and Training Grant Application to PCCD in the amount of \$1,440. This money is to be used for a recidivism study.

John Shireman of Jersey Shore commented on the \$2 Million water and sewer improvements near the golf course. There is a lot of development east and south of Williamsport. To the west of Williamsport there is no initiative. He feels that there should be a focus on existing businesses in the community. He also said that there is an issue with the dike certification. Lastly he feels that commissioners should not oppose the proposed business in Muncy [Delta Thermo Energy].

- Mr. Mirabito explained the reasons behind the \$2 million investment. The three Commissioners also have concerns regarding the levee.
- Mr. McKernan agreed that they all share concerns with the levee.
- Mr. Mussare suggested that a I-99 corridor designation would help with opportunities west of the city.
- Larry Stout, Montgomery, announced that Mr. Mirabito will be receiving recognition from the PA Library Association for his exemplary service.

Elliot Walker of Williamsport said he still is homeless and needs assistance. Mr. Mirabito asked to speak with him after the meeting.
