OPERATIONS 1.0

- CONVENE COMMISSIONERS MEETING. Mr. McKernan convened the Commissioners Meeting 10:07 a.m.
- 1.3 RECEIVE PUBLIC COMMENTS (AGENDA ITEMS ONLY). Mr. McKernan opened the floor to public comment on agenda items only, and none were received.

2.0 ACTION ITEMS

- 2.1 AWARD CONTRACTS FOR FOOD PRODUCTS. A motion by Mr. Mussare and seconded by Mr. Mirabito and passed (3-0), awarded contracts for food products to Benjamin Foods LLC, Feesers Inc, Keyco Dist. Inc. and Sysco Central Pennsylvania on a per item and as needed basis.
- APPROVE REVISION TO POLICY 504.1. A motion by Mr. Mirabito and seconded by Mr. Mussare and passed (3-0), approved revision to Policy 504.1 - Travel and Business Related Expense Policy of the County's Policy and Procedures Manual.
- 2.3 APPROVE UPDATE TO PURCHASE PRICE. A motion by Mr. Mussare and seconded by Mr. Mirabito and passed (3-0), approved the update to the total purchase price of maintenance equipment for White Deer Golf Course from TESCO & Finch as approved on June 9, 2016 from \$149,980.63 to \$158,430.17.

- Mr. Mirabito commented that this money is coming from the 2012 bond money.
- 2.4 APPROVE PURCHASE FROM FINCH SERVICES. A motion by Mr. Mirabito and seconded by Mr. Mussare and passed (3-0), approved purchase of 2 turbine blowers in the amount of \$14,000 from Finch Services, Inc. for the White Deer Golf Course off of state contract.
- 2.5 APPROVE AGREEMENT WITH TIOGA COUNTY. A motion by Mr. Mirabito and seconded by Mr. Mussare and passed (3-0), approved agreement with Tioga County for inmate housing in the amount of \$60/inmate/day.
- 2.6 APPROVE PSA WITH KEYSTONE COMMUNICATIONS. A motion by Mr. Mussare and seconded by Mr. Mirabito and passed (3-0), approved professional service agreement with Keystone Communications LLC not to exceed \$35,755.22.
- 2.7 APPROVE RERF GRANT AGREEMENT. A motion by Mr. Mussare and seconded by Mr. Mirabito and passed (3-0), approved PEMA Radiation Emergency Response Fund Grant agreement in the amount of \$5,876.

5.0 REPORTS / INFORMATION ITEMS.

- 5.2 The Commissioners presented the award from AM Vets the county received for hiring veterans.
- Mr. McKernan explained this is a national award.
- 5.3 The Commissioners presented the Five Star Service award to Veterans Affairs.
- Mr. Heiges announced this is the fifth year in a row that Lycoming County received this award. It represents over \$1.5 million in claims.
- 5.4 Mya Toon announced that Lycoming County is requesting bids for sale of real property. This is for 12.41 acres on Warrensville Road. The minimum reserve is \$300,000.
- 5.5 John Yingling provided an explanation of the September 22, 2016 communications outage information. The 911 system and CAD were not affected. Contingencies were in place to deal with this.

6.0 COMMISSIONER COMMENT.

- Mr. Mirabito reminded the public that the airport will be present on Tuesday, October 4, to do a presentation on the need for a new terminal building.
