1.0 OPERATIONS

- 1.1 CONVENE COMMISSIONERS MEETING. Mr. Mussare convened the Commissioners Meeting 10:01 a.m.
- 1.2 APPROVE THE MINUTES OF THE PREVIOUS MEETINGS. A motion by Mr. Mirabito and seconded by Mr. Mussare and passed (2-0), approved the minutes of the previous meeting as they are recorded.
- 1.3 RECEIVE PUBLIC COMMENTS (AGENDA ITEMS ONLY). Mr. Mussare opened the floor to public comment on agenda items only, and none were received.

2.0 ACTION ITEMS

- 2.1 PROCLAIM DOMESTIC VIOLENCE AWARENESS MONTH. A motion by Mr. Mirabito and seconded by Mr. Mussare and passed (2-0), approved October as Domestic Violence Awareness month in Lycoming County.
- Judge McCoy offered that on October 19 there would be a vigil of remembrance. She gave statistics of domestic violence and recognized those organizations and individuals who assist those going through this.
- 2.2 APPROVE PSA WITH MAXIMUS, INC. A motion by Mr. Mirabito and seconded by Mr. Mussare and passed (2-0), approved

- professional service agreement with Maximus, Inc. in the amount of \$3,000 for one year.
- Beth Johnston explained this is for support of the cost allocation plan.
- 2.3 APPROVE MOU WITH WEST BRANCH D&A. A motion by Mr. Mirabito and seconded by Mr. Mussare and passed (2-0), approved memorandum of understanding with Branch Drug & Alcohol for Act 198 in the amount of \$30,000.
- Mya Toon explained this is for assessment and treatment of adults with substance abuse issues.
- 2.4 APPROVE MOU WITH WEST BRANCH D&A. A motion by Mr. Mirabito and seconded by Mr. Mussare and passed (2-0), approved memorandum of understanding with Branch Drug & Alcohol for Act 198 in the amount of \$44,000.
- Mya Toon explained this is for assessment and treatment of individuals located in the prison and pre-release center with substance abuse issues.
- 2.5 APPROVE MOU WITH WEST BRANCH D&A. A motion by Mr. Mirabito and seconded by Mr. Mussare and passed (2-0), approved memorandum of understanding with Branch Drug & Alcohol for Act 198 in the amount of \$15,000.
- Mya Toon explained this is for prevention and case management of juveniles with substance abuse issues.
- 2.6 APPROVE PSA WITH DYNAMIC IMAGING SYSTEMS. A motion by Mr. Mirabito and seconded by Mr. Mussare and passed (2-0), approved professional service agreement with Dynamic Imaging Systems for the County Prison.
- 2.7 APPROVE PSA WITH GLICK ASSOCIATES. A motion by Mr. Mirabito and seconded by Mr. Mussare and passed (2-0), approved professional service agreement with Glick Associates, Inc. for RMS.
- 2.8 APPROVE SUBRECIPIENT AGREEMENT WITH STEP. A motion by Mr. Mirabito and seconded by Mr. Mussare and passed (2-0), approved subrecipient agreement with STEP for 2015 PHARE.
- 2.9 APPROVE AGREEMENT WITH STEP. A motion by Mr. Mirabito and seconded by Mr. Mussare and passed (2-0), approved agreement with STEP for 2014 PHARE for homes in need program for the Brodart Neighborhood Improvement Project.

- 7.0 PUBLIC COMMENT. Mr. Mussare opened the floor to public comment and the following were received:
 - Jim Dunn from Armstrong Township commented on the Board vacances and asked that potential conflicts be recognized. He also suggested that individuals take courses so they have the appropriate background to serve.
 - Mr. Dunn discussed the Growing Greener Trust and offered suggestions for what needs to be done for a project to be eligible for the funds. He gave examples of the Ridge Trail and Sylvan Dell projects and said that South Williamsport, Duboistown and Armstrong Township are all in favor.
 - Mr. Mirabito suggested to put together a steering committee to follow through with this.
 - Frank Steckel of Williamsport spoke about an issue he has with the Adult Probation Office. He said the state police never reviewed the video according to his 'source'. He said that he cannot talk to anyone in APO and was told not to go there. He also said that Detective Weber will not return his calls.
 - Mr. Mirabito said to file a right to know request.
 - Mr. Steckel claimed he is the victim and the Commissioners are being lied to.
