1.0 OPERATIONS

- 1.1 CONVENE COMMISSIONERS MEETING. Mr. McKernan convened the Commissioners Meeting 10:06 a.m.

- 2.15 APPROVE AGREEMENT WITH WILLIAMSPORT MUNICIPAL AIRPORT

 AUTHORITY. A motion by Mr. Mussare and seconded by Mr.

 Mirabito and passed (3-0), approved agreement with

 Williamsport Municipal Airport Authority for airport terminal funding.
- Mr. Mirabito said this is a difficult decision. The idea of a loan instead of ACT 13 funds. A PIB loan for 1.75% for 10 years would be better. He referred to Elmira Airport. He

- also encouraged wording to be included in the agreement to allow for funding to be controlled.
- Mr. McKernan stated he already feels that we can control this in other ways (like an outside agency annual funding), and the County will fund it as it sees fit.
- Mr. Mussare said that a loan can not be used to match RCAP grant Money. He encouraged that the Cloud 9 restaurant be included in the proposed new terminal, and that the Danielle family be the ones to run it.
- Tom Hart explained that there will be a concession area and that the southern exposure is all glass.
- Mr. Mussare said that regarding ACT 13 funds should be used to leverage money responsibly. Three million dollars to a \$13 million project is a good use. He does not want to leave debt to our children's children. We have the money now, lets use it instead of borrowing money.
- Mr. McKernan said he is concerned with the fund balance if ACT 13 money is used. He thinks a loan is a better choice.
- Mr. Hart explained that remodeling/expanding the current facility was looked at and it would have not been cost effective compared to building a new terminal.
- Mr. Mirabito suggested that UPMC may be helpful in assisting with the terminal building and acquiring flights to Pittsburg.
- Mr. Hart said there is no guarantee for additional airlines. But a new terminal will provide better opportunities due to being able to service regional jets. He explained that money was saved by not including a restaurant in the proposed new terminal. There will be a lease buy out when the time comes. It will be two to two and a half years from groundbreaking to the new terminal being usable.
- Mr. Mirabito asked if the airport is in the floodplain.
- Tom Hart, Executive Director of the Airport said that only the lower end is, the flood waters do not come up to the terminal area.
- Mr. Mirabito thanked him for his transparency.
- Mr. Mussare thanked everyone involved for the hard work.

Mr. McKernan recessed the Commissioners' Meeting at 11:13 a.m.
