1.0 OPERATIONS

- <u>1.1 CONVENE COMMISSIONERS MEETING.</u> Mr. McKernan convened the Commissioners Meeting 10:04 a.m.
- 1.2 APPROVE THE MINUTES OF THE PREVIOUS MEETINGS. A motion by Mr. Mussare and seconded by Mr. Mirabito and passed (3-0), approved the minutes of the previous meeting as they are recorded.
- 1.3 RECEIVE PUBLIC COMMENTS (AGENDA ITEMS ONLY). Mr. McKernan opened the floor to public comment on agenda items only, and none were received.

2.0 ACTION ITEMS

- 2.1 PROCLAIM CORRECTIONS PROFESSIONALS WEEK. A motion by Mr. Mussare and seconded by Mr. Mirabito and passed (3-0), approved Proclaim May 7-13, 2017, as Corrections Professionals Week.
- 2.2 APPROVE PROJECT MODIFICATION REQUEST. A motion by Mr. Mirabito and seconded by Mr. Mussare and passed (3-0), approved project modification request to PCCD for Intermediate Punishment Program grant.
- 2.3 APPROVE PO TRAINING. A motion by Mr. Mussare and seconded by Mr. Mirabito and passed (3-0), approved sending to adult probation officers for Cyber Supervision training in the

amount of \$600, but tabled the memorandum of understanding portion.

- 2.5 TABLE PURCHASES FOR GOLF COURSE. A motion by Mr. Mirabito and seconded by Mr. Mussare and passed (3-0), tabled the following purchases totaling \$80,950 after discussion:
- Toro 300 gallon sprayer from Finch Services, Inc. in the amount of \$30,000 (PA state contract).
- (2) Pro Gator heavy duty utility carts from Finch Services, Inc. in the amount of \$30,000.00 (PA state contract).
- (3) TX gator light duty utility carts from Finch Services, Inc. in the amount of \$4.000 (PA state contract).
- Landpride seeder from Jamco Products in the amount of \$6,955.
- Purchase of Soil Reliever deep tine aerifier from Jamco Products in the amount of \$9,995.
- Mr. Mirabito suggested that the leadership look at borrowing items from other Billy Casper managed courses instead of buying these items.
