1.0 OPERATIONS

- 1.1 CONVENE COMMISSIONERS MEETING. Mr. McKernan convened the Commissioners Meeting 10:06 a.m.
- 1.2 APPROVE THE MINUTES OF THE PREVIOUS MEETINGS. A motion by Mr. Mussare and seconded by Mr. Mirabito and passed (3-0), approved the minutes of the previous meeting as they are recorded.

3.0 SALARY BOARD

- <u>3.1 CONVENE SALARY BOARD</u>. Controller Rogers was absent. District Attorney Linhardt was present for item 3.2.
- 3.2 APPROVE LIST OF SPECIAL COUNTY DETECTIVES A motion by District Attorney Linhardt and seconded by Mr. Mussare and passed (4-0), approved the attached list of roving DUI patrols for the period 7/1/2017 through 12/31/2018.
- The District Attorney presented the following information before the item was voted on:
- The approval of this list of special county detectives serves to provide them with county-wide jurisdiction. This is being funded through a PennDoT grant since 1996 and it has been administered by Old Lycoming Township. Lycoming is one of four counties funding by the states for DUI check points and roving patrols. This grant funds four checkpoints/year and 36 roving patrols. Over the past five years (2012-2016) there has been a 10% decline in DUI offenders. The percentage of drug related stops has doubled. The percentage of DUI offenders that would be eligible for ARD has decrease by 1/4. These stops not only lead to the arrests for DUI offenders, but produce arrests related to felony and misdemeanors as well, including but not limited to drug dealers, illegal firearms, fugitives, stolen vehicles, underage drinking, and Megans law offenders. Three who have been wanted for homicide have been apprehended through this initiative. Defendant Grady Neal was apprehended at 3:00 a.m. by a DUI patrol and charged with alcohol and marijuana. He also was charged with possession and intent to deliver cocaine. DA Linhardt detailed the items that were discovered in his car.
- 3.3 ADJOURN SALARY BOARD. A motion by Mr. Mussare and seconded by Mr. Mirabito and passed (3-0), adjourned the Salary Board at 10:24 a.m.

AND NOW, comes Eric R. Linhardt, Esquire, District Attorney for Lycoming County, and respectfully represents the following:

- 1. The Lycoming County Office of District Attorney is engaged in the investigation of criminal activities, including but not limited to the operation of Sobriety Checkpoints and DUI Roving Patrols.
- 2. The various Sobriety Checkpoints and DUI Roving Patrols will be located in Lycoming County, Pennsylvania.
- 3. Various members of the municipal police departments in Lycoming County will be participating in the Sobriety Checkpoints and the DUI Roving Patrols within the 2017-2018 calendar years.
- 4. It will be necessary for those individuals participating in the Sobriety Checkpoints and DUI Roving Patrols to have appropriate law enforcement authority to execute their duties.
