1.0 OPERATIONS

- 1.1 CONVENE COMMISSIONERS MEETING. Mr. McKernan convened the Commissioners Meeting 10:08 a.m.
- 1.2 APPROVE THE MINUTES OF THE PREVIOUS MEETINGS. A motion by Mr. Mirabito and seconded by Mr. Mussare and passed (3-0), approved the minutes of the previous meeting as they are recorded.
- 1.3 RECEIVE PUBLIC COMMENTS (AGENDA ITEMS ONLY). Mr. McKernan opened the floor to public comment on agenda items only, and the following were received.
- Todd Lauer of Jersey Shore provided the attached regarding the 2018 budget.
- Scott Miller of Williamsport advises the Commissioners to spend wisely and noted that he would rather have small tax increases over the years rather than one large tax increase all at once.
- Todd Lauer also noted with regard to item 2.1, that he doesn't feel the current board of commissioners should pass contracts that extend past their term.

2.0 ACTION ITEMS

2.1 APPROVE AGREEMENT WITH CONDUENT ENTERPRISE SOLUTIONS, LLC. A motion by Mr. Mussare and seconded by Mr. Mirabito and passed (3-0), approved agreement for information technology products and services through July 31, 2022.

- 2.2 APPROVE PURCHASE FROM DRS IMAGING GROUP OF MICROFILM SCANPRO 2200--2018. A motion by Mr. Mirabito and seconded by Mr. Mussare and passed (3-0), approved this purchase in the amount of \$12,263.85.
- 2.3 APPROVE QUOTE FROM CLEVELAND BROTHERS EQUIPMENT COMPANY, INC. A motion by Mr. Mirabito and seconded by Mr. Mussare and passed (3-0), approved the quote for replacement parts and labor in the amount of \$13,112.29.

- 2.7 APPROVE EQUIVANT LICENSE ADJUSTMENT. A motion by Mr. Mirabito and seconded by Mr. Mussare and passed (3-0), approved the adjustment resulting in a credit due to Lycoming County.

He feels strongly that we need to invest in our community by bringing people to our area through advertisements.
- **8.0 NEXT REGULARLY SCHEDULED MEETING.** Mr. McKernan announced the next regularly scheduled meeting as a work session on Tuesday, November 14, 2017.

COMMISSIONER RICK MIRABITO

NOVEMBER 2, 2017

As we know, the budget is scheduled to be voted on December 7, 2017. That is approximately 5 weeks from now.

As I reflect on the budget situation, I have concluded that the only way we will get the deficit under control is through disciplined planning and execution of our proposals.

I also am convinced that we need the participation and cooperation of the Department Heads and Elected Officials in this process.

I am equally concerned about the urgency of this action. In order to gain these savings for fiscal year 2019, we need to complete these actions in 2018.

I make a motion today that in order to effectuate the staff reduction which is an important component of our deficit reduction plan we take the following actions:

- Send tomorrow, November 3, 2017, by written communication to all Department Heads
 and Elected Officials notification for them to identify at least two positions which they
 would eliminate in the next calendar year based on attrition or reorganization of their
 departments.
- Inform the Department Heads and Elected Officials that we need this information from them by November 22, 2017.
- The Commissioners will take this information and draft a written plan to reduce the number of employees in calendar year 2018.
