1.0 OPERATIONS

- 1.1 CONVENE COMMISSIONERS MEETING. Mr. McKernan convened the Commissioners Meeting 10:05 a.m.

Both Commissioners McKernan and Mussare feel that the \$60 should have simply been paid to avoid this situation.

7.0 PUBLIC COMMENT. Mr. McKernan opened the floor to public comment and the following were received:

Todd Lauer- Jersey Shore – with regard to the 2018 budget Mr. Lauer questioned the following and expressed his feelings regarding these expenditures:

- 1. Mr. Lauer disagrees with the county paying for counseling for inmates.
- 2. Mr. Lauer disagrees with paying for postage for the Sheriff to send out permit renewal reminder.
- 3. Mr. Lauer also questioned why notices are sent out both certified and regular mail.
- 4. Mr. Lauer questioned why, when there is a federal prison so close by, would Lycoming County Prison house federal inmates.
- 5. Mr. Lauer questioned the purchase of weapons for the prison.
- 6. Mr. Lauer expressed his dissatisfaction with the DA getting less money this year for the drug unit.

Unrelated to the budget, Mr. Lauer raised the issue of an incident that occurred at the landfill where an employee damaged county equipment, a customer's vehicle, and

jeopardized the safety of this customer. Mr. Lauer wants to know who is responsible for paying for the damage and whether the employee will be disciplined

- **8.0 NEXT REGULARLY SCHEDULED MEETING.** Mr. McKernan announced the next regularly scheduled meeting is Thursday, December 7, 2017. Nicki Collins reported that there will be a bid opening on Tuesday, December 5, 2017 in the Commissioner's Board Room.
