1.0 OPERATIONS

- <u>1.1 CONVENE COMMISSIONERS MEETING.</u> Mr. McKernan convened the Commissioners Meeting 10:05 a.m.
- <u>1.2 APPROVE THE MINUTES OF THE PREVIOUS MEETINGS.</u> A motion by Mr. Mussare and seconded by Mr. Mirabito and passed (3-0), approved the minutes of the previous meeting as they are recorded.
- <u>1.3 RECEIVE PUBLIC COMMENTS (AGENDA ITEMS ONLY).</u> Mr. McKernan opened the floor to public comment on agenda items only, and none were received.

2.0 ACTION ITEMS

- <u>2.1 ADOPT RESOLUTION 2017-36.</u> A motion by Mr. Mirabito and seconded by Mr. Mussare and passed (3-0), adopted Resolution 2017-36 for renewal of collateral security note for the Joinder Board line of credit.
 Beth Johnston explained this is an annual renewal for a line of credit.
- 2.2 APPROVE PSA WITH CONTRAST COMMUNICATIONS. A motion by Mr. Mirabito and seconded by Mr. Mussare and passed (3-0), approved professional service agreement with Contrast Communications, not to exceed \$100,000.

- 2.3 APPROVE QUOTE FROM MITEL BUSINESS SOLUTIONS. A motion by Mr. Mussare and seconded by Mr. Mirabito and passed (3-0), approved quote from Mitel Business Systems in the amount of \$13,167.14.
 Leslie Kilpatrick explained this is support for the phone system.
