## 1.0 OPERATIONS

- 1.1 CONVENE COMMISSIONERS MEETING. Mr. McKernan convened the Commissioners Meeting 10:06 a.m.
- 1.2 APPROVE THE MINUTES OF THE PREVIOUS MEETINGS. A motion by Mr. Mirabito and seconded by Mr. Mussare and passed (3-0), approved the minutes of the previous meeting as they are recorded.
- 1.3 RECEIVE PUBLIC COMMENTS (AGENDA ITEMS ONLY). Mr. McKernan opened the floor to public comment on agenda items only, and none were received.

### 2.0 ACTION ITEMS

2.1 APPROVE INCREASE IN 2018 ACTURIAL EMPLOYER CONTRIBUTION (ADEC). A motion by Mr. Mirabito and seconded by Mr. Mussare passed (3-0) to allow for the increase in the amount of \$241,229.04 and an additional vote for the disbursement of these funds will be required.

Mr. Mussare – Federal and State governments are broke. It's nonsense. They have borrowed billions of dollars. We are going down the road of destruction here. Look at Detroit's pensions, nothing is guaranteed. We have to open our eyes about these pensions. What happens if the stock market drops? We cannot continue to do this.

Mr. Mirabito – This is a difficult situation. Small businesses can't afford to provide pensions like these. Pensions keep people out of poverty after they have

given many years of service. I am okay with putting money in to retirement, this is not a handout. The employees contribute 8%. I appreciate what Mr. Mussare is saying, we have to be cognizant.

Ms. Brelsford/ Mr. McKernan agreed that county employees have nothing to worry about; the pension is 96% funded. Lycoming County is doing excellent funding the pensions in comparison to other counties across Pennsylvania.

- 2.5 APPROVE PSA WITH MCCLURE COMPANY. A motion by Mr. Mirabito and seconded by Mr. Mussare and passed (3-0), approved to provide services related to HVAC systems.
- 2.6 APPROVE AMENDMENT NO.2 OF THE 2017 -2018 MAHANTANGO

  ENTERPRISES, INC AGREEMENT. A motion by Mr. Mirabito and seconded by Mr. Mussare and passed (3-0), approved a one year extension of the Tire Recycling agreement.
