PROCLAMATION

WHEREAS, Domestic violence has affected members of our community and individuals throughout the world. WHEREAS, Williamsport YWCA – Wise Options is dedicated to help victims of domestic violence by providing advocacy, education, services and resources. Through their programs, individuals and families can feel a sense of hope, safety, and protection; and

WHEREAS, Lycoming County encourages members of the community to work together to increase domestic violence awareness. Doing so will enable members of our community to feel safe and secure.

NOW, THEREFORE, BE IT RESOLVED that the Commissioners of Lycoming County hereby proclaim October 20, 2022:
