Comments on Old City Project

Last Thursday July 28th at the Lycoming Board of Commissioner Public meeting a vote was approved 2-0 to approve 1,012,240 in funding to Old City Williamsport LLC for the East End gateway Project.

First, I would like to commend Dr. Kent Trachte and the Board of Directors of Lycoming College for their vision for the college and the City of Williamsport. They have accomplished many of their goals over the past several years to improve the college and the city.

Next, I would like to thank Pine Ridge Construction Management for investing in our community.

Both entities are investing millions of dollars for education and economic development into this section of our community.

I have been supportive of the East End Gateway Project and the Old City Revitalization.

My further comments are in no way against either entity or the overall project.

Last week was the first commissioners meeting I have missed in three years due a planned vacation with my wife.

On Tuesday July26th · my two colleagues called me while I was on vacation to express that they had met with the college and the developers and the college and developer were requesting a million dollars towards the project for a parking garage. It is my understanding that this garage is 40,000 sq. ft. with 165 parking stalls. Commissioner Mirabito made note that the county would receive 42 spaces. I stated to both of them that I was not ready at that point to commit to that amount of money as I had several questions that needed answered. Some of those questions were what amount is the city willing to investing, where the money was being allocated from among other questions. Commissioner Mussare stated that he was calling to see if I would agree to place it on a future agenda. As

the chairman, I am the one that sets the agenda and I agreed that when I returned from vacation I would place it on a future agenda. They noted the Governor recently reopened the RACP grant process that had a short window till August 19th.

On Thursday July 28th my two colleagues called me after the Commissioner's Public meeting to advise me that they amended the agenda to add the request for funding to Old City Williamsport LLC for the East End Gateway Project. They approved the requests after a 2-0 vote for the monies to be allocated from the ARPA funds that the county has received.

The County would be contributing 3.8%, the City 3.1% and the state another 4 percent of the total project with the college and developer paying approximately 89% of the plan.

I believe my colleagues did not have prior knowledge that Dr. Trachte nor the developer were going to be in attendance that morning. Nor do I believe that Dr. Trachte nor the developer did anything wrong. It was my understanding that it was a miscommunication about the timing of when the item was going to be place on the agenda.

What I find disturbing about this action that was voted and approved so quickly without the consideration of the chairman. In 72 hrs. a million dollars was discussed, voted and passed.

My colleagues could have attempted to contact me by phone to join the meeting or could have stated that the chairman is not available this morning but out of respect we will table this till next Thursday since he stated that he had several questions.

I fully understand that there is a deadline for the RACP grant and process of August. From speaking with a state official that is knowledgeable of the process, the homework could have been completed and a decision by the Commissioners could have been prior to the deadline.

So this decision was made without my input and my questions being answered. Also the monies are being taken from the ARPA funds that are being discussed by the three Commissioners. I am not sure which category these monies will fall under. Therefore, the chairman did not have the opportunity to vote on a million dollar allocation of our 22 million dollar allocation. This is the 2nd decision that

day I was not privileged to vote on.

This is a decision that involved one million dollars that warranted all three of our input.

Since my return from vacation I have been informed the City has not yet voted and approved their 3.1% of the overall project as reported.

It is wrong how this matter was handled last week and does not display good government. I would hope that in the future that my colleagues would be more mindful moving ahead so monies are allocated with all three of us involved in the decision making process

We are all elected officials and when one of us is excluded it is a slap in the face of the voters that placed that individual in office. The office of Commissioner was designed to make sure that the three of us have representation. We need to make sure that happens.
