Dear Lycoming County Commissioners,

I read in the Sun Gazette that you invited public comment on the potential action to work with a private developer on this proposal to buy the Lycoming Mall. Please accept this letter as my comments speaking as a Certified Professional Planner and independent with no affiliation with that developer.

I walked the Mall last week. The vacant stores offer potential for a VARIETY OF REUSES – not just commercial! Developers will have to get creative.

Zoning may need to be adjusted to allow MIXED USE OPTIONS!

For example:

Retail Commercial services Elder housing/ public housing Medical Services/ Health Clinics Retail pharmaceutical Rental apartments Community Centers Professional offices

Examples of other uses for malls and big-box stores:

- The Under Armour headquarters in Baltimore, Maryland, sits on a 58-acre site once home to a Sam's Club and several other businesses.
- A former Meijer grocery store in Greenville, Michigan, is now the Rock City Indoor BMX track
- A one-time Sam's Club in Olathe, Kansas, has a new life as the Heartland Community Church
- · An Indianapolis Toys "R" Us became a charter school
- · There are various examples of malls coming back with a new purpose, too:
- The Mayfield Mall in Mountain View, California, is currently one of Google's headquarters
- · The Hickory Hollow Mall in Antioch, Tennessee, has become a skating rink
- In Englewood, Colorado, the Cinderella City Mall now features residential units, retail shops, offices, and an art museum

When I was Executive Director of Lycoming County Planning Commission the emerging NEW REQUIREMENTS for storm water run off, and its impact on stream quality were subject to stringent new standards of USEPA and the Chesapeake Bay Commission. Therefore we required a storm water collection pond on the property and later phases of the parking areas were required to be porous pavement.

The Black Friday surge in retail activity drove us to require huge parking lot capacities. Today with on-line retailing those patterns have changed. Therefore reuse options should include reuse of parts of the parking lots.

The interior mall corridors provide a save space for people to walk protected from the weather and traffic.

The world is changing but large spaces remain useful and can benefit society beyond their original purpose.

Therefore, I do support the County Commissioners to enable a private developer to purchase the mall and hopefully undertake significant reuse options.
