ENTITLED "Lycoming County gov't complies with right-to-know request." THE

ARTICLE WAS ABOUT THE MEETING HELD ON MARCH 10 AT WHICH THE

COMMISSIONERS VOTED TO APPROVE THE REORGANIZATIONOF THE

INFORMATION SERVICES DEPARTMENT.

I WAS ABSENT FROM THE MARCH 10 MEETING DUE TO AN ILLNESS IN MY FAMILY,
AND I DID NOT PARTICIPATE IN THE MEETING.

THE ARTICLE REPORTED THAT THE SUN-GAZETTE HAD FILED A RIGHT-TO-KNOW REQUEST TO FIND OUT THE SPECIFIC AMOUNTS THAT THE COMMISSIONERS HAD APPROVED TO PAY EACH EMPLOYEE AS A RESULT OF THE REORGANIZATION.

FIRST, ALTHOUGH I DID NOT PARTICIPATE IN THE MEETING, I WILL APOLOGIZE

TO THE SUN-GAZETTE AND THE PUBLIC FOR THE FACT THAT A RIGHT-TO-KNOW

REQUEST HAD TO BE FILED TO OBTAIN INFORMATION THAT BELONGS TO THE

PUBLIC. CONTINUED

AS THE PUBLIC MAY NOTICE, ABOUT 6 WEEKS AGO WE CHANGED THE WAY THAT
WE REPORT PERSONNEL CHANGES AND THE SALARY CHANGES IN OUR AGENDA.

LET ME EXPLAIN HOW WE ARRIVED AT THIS JUNCTURE.

THE COMMISSIONERS HAVE BEEN CONCERNED ABOUT MORALE ISSUES WITH EMPLOYEES AND, IN PARTICULAR, DISSATISFACTION WITH COMPENSATION.

THE COMMISSIONERS BELIEVED THAT SOME OF THESE MORALE ISSUES WERE DRIVEN BY THE PUBLICATION EACH WEEK OF SALARIES AND CHANGES THAT RESULTED FROM REORGANIZATIONS, PROMOTIONS, OR OTHER CHANGES IN COMPENSATION.

AFTER DELIBERATION, WE DECIDED TO TERMINATE THE PUBLICATION OF
THE WAGE AND SALARY INFORMATION EACH WEEK.

WE AGREED TO CONTINUE TO RELEASE AT THE END OF EACH MONTH THE SUMMARY OF PERSONNEL ACTIONS WITH WAGE AND SALARY CHANGES.

AFTER OBSERVING THE PRACTISE FOR 6 WEEKS, I HAVE CONCLUDED THAT THE PRACTISE IS INEFFECTUAL AND NOT CONSISTENT WITH OPEN. TRANSPARENT GOVERNMENT.

THE REASON THAT THE PRACTISE IS INEFFECTUAL IS THAT EMPLOYEES STILL WILL SPEAK WITH EACH OTHER AND SPECULATE ABOUT THE WAGE AND SALARY CHANGES. INDEED, THE LACK OF SPECIFIC INFORMATION SIMPLY FEEDS A RUMOR MILL THAT HAS WORSE OUTCOMES.

MORE IMPORTANT THAN THE MORALE ISSUE, HOWEVER, IS THE ISSUE OF DEPRIVING THE PUBLIC FROM INFORMATION ON A TIMELY BASIS ABOUT HOW GOVERNMENT OFFICIALS SPEND THEIR TAX DOLLARS.

WE SHOULD NOT DENY THE INTRINSIC RIGHT OF THE PUBLIC TO KNOW ABOUT EXPENDITURES OF TAX DOLLARS IN AN ATTEMPT TO DEAL WITH AN EMPLOYEE MORALE ISSUE.

THE COUNTY'S POLICY ON INFORMATION MIRRORS THE STATE RIGHT-TO-KNOW

LAW: ALL INFORMATION THAT IS NOT EXEMPT INN SOME WAY IS PUBLIC

INFORMATION AND SHOULD BE MADE AVAILABLE TO THE PUBLIC WITHOUT

THE PUBLIC HAYING TO FILE A RIGHT-TO-KNOW REQUEST.

THE RIGHT-TO-KNOW REQUEST IS ONLY A TOOL TO PROTECT GOVERNMENT
OFFICIALS FROM ALLEGATIONS THAT NOT ALL INFORMATION HAS BEEN
PROVIDED.

THE RIGHT-TO-KNOW REQUEST SHOULD NOT BE AN ANTECEDENT ACTION

NECESSARY TO OBTAIN PUBLIC INFORMATION. IN OTHER WORDS, THE PUBLIC

SHOULD NOT HAVE TO JUMP THROUGH HOOPS TO FIND OUT HOW

GOVERNMENT OFFICIALS SPEND THEIR TAX DOLLARS.

THE FACT THAT WE PUBLISH THE INFORMATION AT THE END OF THE MONTH DOES

NOT PROVIDE THE PUBLIC WITH TIMELY, UP-TO-DATE INFORMATION.

THE ABSENCE OF TIMELY INFORMATION IS MORE LIKELY TO ENCOURAGE THE PUBLIC TO **DISENGAGE** FROM GOVERNMENT.

IF I RECALL CORRECTLY, I MADE THE MOTION IN MY FIRST TERM TO PUBLISH THE
MONTHLY SUMMARY OF PERSONNEL ACTIONS. THAT MOTION WAS NOT TO
REPLACE THE PRACTISE THAT WE HAD OF PROVIDING THE INFORMATION ON A
WEEKLYBASIS.

ACCORDINGLY, I AM SEEKING TO REACH A CONSENSUS WITH MY FELLOW

COMMISSIONERS THAT WE RETURN TO THE PRACTISE OF PUBLISHING THE WAGE

AND SALARY INFORMATION EACH WEEK WHEN WE VOTE ON THE ISSUE WHICH

GIVES RISE TO THE CHANGE. THIS IS THE PRACTISE THAT WE HAVE UTILIZED FOR

AT LEAST THE PAST 10 YEARS AND POSSIBLE LONGER.

I BELIEVE THAT THE PRACTISE SERVES THE PUBLIC WELLAND FULFILLS OUR
RESPONSIBILITY TO HAVE OPEN, TRANSPARENT GOVERNEMENT WHICH
EMPOWERS THE PUBLIC TO HOLD ELECTED OFFICIALS ACCOUNTABLE FOR
THEIRACTIONS.

WHEREAS, the month of April 2022 recognized as "Pennsylvania 811 Safe Digging Month", and the initiative sponsored by Pennsylvania 811, a utility notification information center celebrating its 50<sup>th</sup> year of continuous service to the Commonwealth of Pennsylvania, and

WHEREAS, Pennsylvania 811 received close to 1,050,000 excavation notifications in 2021, and transmitted approximately 6.7 million notifications to their member facility owners and operators allowing essential utility and construction crews to provide vital underground services and repair of critical infrastructure to communities throughout Pennsylvania, and

WHEREAS, when dialing 811, at least three business days before digging, a homeowner or a contractor is connected to a unique service that notifies the appropriate underground utility operators in the municipality in which the work will be performed, and

WHEREAS, by notifying 811 of their intent to dig, the homeowner or contractor is knowingly helping to protect the underground utilities, themselves, the work crew, and their neighbors from any unsafe digging practices within their community, and

WHEREAS, upon receiving the notification from Pennsylvania 811, the facility owners and operators disperse to the said work site to mark the approximate location of their underground utility lines with flags, paint, or both, to establish an eighteen-inch tolerance zone of the outside wall or edge of their line or facility, and

NOW, THEREFORE, BE IT RESOLVED that The County of Lycoming Pennsylvania in support of the Pennsylvania Underground Utility Line Protection Law, PA Act 287 of 1974, as amended, we do hereby proclaim April 2022 as "Pennsylvania 811 Safe Digging Month", and encourage all Pennsylvanians to visit the Pennsylvania 811 website at <a href="https://www.paonecall.org">www.paonecall.org</a> for information about digging safely.
