Added – Jason Fink – Vote and approve City of Williamsport tax exemption under the Local Economic Revitalization Tax Assistance Act (LERTA)

Mr. Fink presented LERTA opportunities/programs for the City of Williamsport and the FamVest Properties in Muncy. He explained that FamVest was looking to have the LERTA in place that would assist them in bringing in tenants. The Muncy School District passed a resolution without a sunset, but will realign with what the County votes to do and add a sunset in. This LERTA is on new expansion, not on the existing property assessment.

Mr. Mirabito moved to add to the existing FamVest XII LERTA a sunset provision that the LERTA terminates 10 years from the date of signing by this board of Commissioners and returns to the current rate of taxation Mr. Mussare  $2^{nd}$  the motion. Approved 3-0

Mr. Mirabito moved to approve the LERTA for FamVest with the sunset provision that just passed. Mr. Mussare 2<sup>nd</sup> the motion. Approved 3-0.

Regarding the Williamsport LERTA, Mr. Fink explained that the City of Williamsport approved a seven-year LERTA for Commercial incentives that starts at 100% and deescalates by 25% every 2 years and at the end. They also brought a residential LERTA to provide incentive for residential development in pockets of the city that need it and to provide incentives to developers to invest in homeowners. This is a 10-year LERTA with 100% abatement over 10 years

Mr. Mirabito made a motion to adopt the entire LERTA agreement, with the sunset motion in it. Mr. Mussare 2<sup>nd</sup> the motion. Approved 3-0

#### **Matt Yonkin- Chief Juvenile Probation Comments:**
