6.0 COMMISSIONER COMMENT

Mr. Mussare spoke to the candidates running for office about their vision and expectations. He encouraged them to stay committed to their core values and try to be a part of the solution. He also noted that he was impressed with all the candidates. He commented on the need to work together as Commissioners, regardless of party lines, all that they will learn while in office and how they can lead, as well as change the outlook of the County. Mr. Mussare also spoke about the House Bill 170. He encourages everyone to educate themselves on this bill and to read the article in today's paper. Per Mr. Mussare, this bill would be devasting to our County and adversely affect home owners as it will infringe upon the rights of homeowners. He asked that people call Senator Yaw's office, as well the state representatives office to voice your concerns.

Mr. Metzger advised everyone that the Veteran s Parade will be held this Saturday, 11/4 at 2pm. He encouraged everyone to come to the parade and show their support for the Veterans.

Mr. Mirabito also addressed the candidates. He talked about some of the things he did as a new Commissioner. He advised them to do a tour of all the departments and talk to the employees without the department heads present. Mr. Mirabito encouraged them to not only

hear, but listen to what people are saying.

7.0 GENERAL PUBLIC COMMENT Speakers who wish to address the Board of Commissioners will be limited for <u>no more</u> <u>than three (3) minutes</u> on any particular item. The speaker must state his/her name and address for the record. Any deviation from this rule must be approved by the Board Chairman.

Larry Stout, Montgomery – Mr. Stout congratulated the Commissioners who were on board and chose to get involved in the Opioid class action suit. He provided them with a copy of an article he found on the internet and asked what was being done with the settlement money. Copy attached

In response, Mr. Mirabito explained that there are stringent regulations on how the money can be used. Generally, it must be used for education and/or prevention. At this time, it is being used in the jail for Medically Assisted Treatment. The program is being administered by River Valley Health Center. Mr. Mirabito explained the program and the rational for using the money for this program. The Prison and West Branch Drug & Alcohol conferred with the Commissioners on ways to utilize the settlement funds. The contracts for the services were voted on at public meetings. Education is also an important part of the program. Shea Madden from West Branch Drug & Alcohol continues to keep them updated on the latest research, ideas and information.

Mr. Mussare reported that he doesn't agree with all the stipulations put ion the settlement. Counties should be able to determine the best ways to use the money. Per Mr. Mussare these short-term solutions aren't the answer. Long term solutions are what is needed. When the prison was overcrowded due to the opioid epidemic GEO Reentry became part of the solution.

Mr. Metzger stated that he agrees with Mr. Mussare regarding the stipulations placed on the settlement. He is in favor of education targeting the youth of the community. However, since medically assisted treatment will soon be court ordered they wanted to get ahead of it and have it already in place.

Tom Adams, Williamsport. Mr. Adams read a proverb and commented on the ancient landmarks that have been removed from today's morals. Mr. Adams agreed that restrictions/ should not have been placed on the settlement monies, but parameters would have been beneficial and better understood. In his opinion the local communities should decide what's best for them. Per Mr. Adams, bureaucracy isn't representative government. Mr. Adams commented on the article in the paper about Bill 170. He also commented on the upcoming elections. He urges people to look at the core values of the person you are voting for. He believes everyone should be respectful while voting and deal with any issues that arise in an appropriate, peaceful manner. Mr. Adams asked questions about the Clear Vision program which the Commissioners answered. Mr. Adams recounted a story about Mr. Mussare being a good public servant.

Search: Opioid settlement payments in Pennsylvania

Pennsylvania counties and other local governments received more than \$86 million in opioid settlement payments for 2022 and are scheduled to receive \$56 million more in the next round of payments.

Each county received payments based on a formula that factored in the harm that occurred in their area. Some counties received additional money based on their role in oploid litigation.

After accounting for attorney costs and fees and certain administrative expenses, 15% of the opioid settlement funds to be distributed in Pennsylvania go to an account that the legislature and governor control. The rest goes to counties and other local governments.

Some county leaders and public health advocates have big hopes for what this money can accomplish.

In northeastern Pennsylvania, Sullivan County — with its tens of thousands of acres of state game lands and a population under 6,000 — received more than \$100,000 for its 2022 payments. That works out to about \$17.50 per resident, one of the highest per-resident rates in the state.

County commissioners there approved using a portion of that money to hire a county case manager and recovery liaison, who's been working to expand access to opioid addiction medication and help get people into treatment programs. The opioid issue is personal for Sullivan County Commissioner Donna Iannone, who said her younger sister died from a heroin overdose many years ago.

"When this money came, it was like, 'Hell, yeah!'" she told Spotlight PA. "We're going to ... make as big an impact on people's lives that we can to keep another family member from having to ever go through that."

Factoring in harm

Overall, 70% of the opioid money that's being sent to government agencies by Pennsylvania's opioid trust is going to counties through an abatement account. Distributions from that account are based on the four-part formula that factors in the harm and need in the area.

For instance, Philadelphia's population of more than 1.5 million people accounts for 12% of the entire state. But under the formula it receives a larger share from that county abatement account — 23% of those funds.
