5.0 COMMISSIONER COMMENT

Mr. Metzger commented on the sale of Executive Plaza and informed the public that if they are interested in the purchase of the building they can contact Mya Toon. Proposals for the purchase of the building must be submitted by 5/4/23. He announced that, with the exception of the Coroners office, the balance of the county offices would be moving to Third Street Plaza. Mr. Metzger thanked the Sun Gazette for their reporting on the open House for the Health Center. Mr. Metzger pointed out the benefits of the Health Center for the County employees and retirees. and how it reduces the cost of Health Care for the County, therefore benefiting the taxpayers. Mr. Metzger expressed the potential for future expansion of the Heath Center by partnering with other government agencies and/or school districts.

Mr. Mirabito commented on the change's health care has undergone over the past 50 years and how these changes have impacted business, employers, employees and the general public. Mr. Mirabito expressed that the best way to drive down the cost of health care is to keep your employees healthy and invested in their own health care. The Health Center provides a way of doing this and taking back control of the costs of health care.

Mr. Mussare expressed his concerns about the American currency system and changes that may be made. He encouraged the American People to start paying attention to what is going on in the world regarding currency, about digital currency that our government is going to try to move toward. He urged people to do their research and try to understand the currency system. Mr. Mussare commented that the changes could have a devasting impact on America. He encouraged everyone to voice their opinion now or you may not have any say in it later.

WHEREAS, the month of April 2023 recognized as "Pennsylvania 811 Safe Digging Month", and the initiative sponsored by Pennsylvania 811, a utility notification information center with over 50 years of continuous service to the Commonwealth of Pennsylvania, and

WHEREAS, Pennsylvania 811 received over 1 million excavation notifications in 2022, and transmitted approximately 6.8 million notifications to their member facility owners and operators allowing essential utility and construction crews to provide vital underground services and repair of critical infrastructure to communities throughout Pennsylvania, and

WHEREAS, when contacting 811, at least three business days before digging, a homeowner or a contractor is connected to a unique service that notifies the appropriate underground utility operators in the municipality in which the work will be performed, and

WHEREAS, by notifying 811 of their intent to dig, the homeowner or contractor is knowingly helping to protect the underground utilities, themselves, the work crew, and their neighbors from any unsafe digging practices within their community, and

WHEREAS, upon receiving the notification from Pennsylvania 811, the facility owners and operators disperse to the said work site to mark the approximate location of their underground utility lines with flags, paint, or both, to establish an eighteen-inch tolerance zone of the outside wall or edge of their line or facility, and

NOW, THEREFORE, BE IT RESOLVED that LYCOMING COUNTY, in support of the Pennsylvania Underground Utility Line Protection Law, PA Act 287 of 1974, as amended, we do hereby proclaim April 2023 as "Pennsylvania 811 Safe Digging Month", and encourage all Pennsylvanians to visit the Pennsylvania 811 website at www.palcall.org for information about digging safely.
