7.0 COMMISSIONER COMMENT

Mr. Metzger announced that there are many Memorial Day Celebrations throughout the county that are open to the public. He asked the public to take time to acknowledge and remember the holiday and those that served. Without these veterans who paid the ultimate price we would not be sitting where we are with our freedoms.

Mr. Mussare thanked Mr. Metzger for taking the time to give a meaningful prayer for the veterans, community and service people. These prayers are appreciated by many.

Mr. Mirabito announced that he attended Senator Yaw's Student Government seminar last week. He remarked about the young people's enthusiasm for getting involved in politics as well as the ability they demonstrate. He described them as a rich talent pool. The challenge is getting them to stay and live her. Mr. Mirabito also commented on Senator Yaw's round table for rural Pennsylvania that they attended. The participants discussed the challenges communities in rural PA face and what is needed to keep the communities vibrant.

Mr. Metzger informed the public that there was a meeting on Monday with the Airport Authority to discuss the challenges they are facing. The Commissioners went on a tour of the facilities yesterday to see the progress of the renovations and those they are hoping will be done by 2024. COVID monies are being used for these projects.

Mr. Mussare explained that Lycoming County received the fourth largest amount of COVID moneys in the state because they had just built the new terminal.

Per Mr. Mirabito when the COVID monies were allocated they looked at what was spent in 2018 to determine the amount awarded. Since 17 million dollars was spent in 2018 on the terminal Lycoming County got the 4th largest ARP money in the state. Mr. Mussare remarked that the 3 million dollars that the county put in from ACT 13 dollars

leveraged almost 30 million dollars in funding.

Mr. Mirabito explained that the TSA requirements were not being met with the old terminal which is why they had to build a new one in order to bring it up to the standards required by law. He further explained that there are two sides to the airport one for commercial aviation and the other for general aviation.

Mr. Metzger explained that the general aviation is for private planes and charters. They have done 4000 flights.

Mr. Mussare reported that the Airport Authority has several pilots on the board that understand the needs of the airport, understand aviation and have the ability to communicate effectively with the networks to move the airport forward. He also stated that due to the general aviation side and the leases they hold the airport will not have to rely on taxpayer dollars.

Mr. Metzger reported that the Commissioners are in communication with the Airport Authority. They have recommended to them that they market what they are doing and accomplishing so the public is more aware and has the correct information.

8.0 GENERAL PUBLIC COMMENT

Tom Adams, Williamsport – Mr. Adams thanked the Commissioners for recognizing the EMS personnel and honoring all those that have served our country for Memorial Day. Mr. Adams commented on the constitution and how the court system is supposed to work. He remarked that the people need to get control of a representative government.
