He gave a brief history of the organization and reviewed some of the projects that they will be working on in the future. He presented the Commissioners with a framed map of the rail system. He pointed out the benefits of the rail

system, excursions for special events and discussed future possibilities.

3.2 John Lavelle – ARPA Presentation – presentation attached

Mr. Mussare commented that this has been a complicated and challenging process to get to this stage. The leadership within the County, County partners, employees and departments working together has made this work. He applauded all those who have worked hard on this project.

Mr. Metzger pointed out that the requests far outweighed the money being awarded. After much research, a plan and budget were developed. We are grateful that we have this money to assist our community. All of the projects chosen will help future generations. They are dispersed throughout the county and span all age groups.

Mr. Mirabito indicated that the process has been very educational in addition to being an example of constituents being involved with County Government. Mr. Mirabito assured the public that they continue to be committed to Early Learning and are working on finding the best path forward. He commented on the need for continued investment in rural America. Mr. Mirabito expressed his pride in what everyone working together has been able to do with a small amount of money by leveraging it and making investments that will be generational. 

## Spinoff Efforts

#### FIRE DEPARTMENT GRANT

Traditional fundraising efforts were severely cut back during Covid

A majority of fire departments were not eligible for APRA funds due to their tax filing status

We created a 1-time grant program where eligible fire companies were awarded \$20,000

- Funded by Act 13
- 28 Volunteer Fire Companies were funded
- Total relief offered: \$560,000

#### HOUSING STARTS INITIATIVE

Grant to help defray cost of required improvements & utility connections in order to spur growth in the market rate housing sector

#### Must:

- Be within a designated growth area
- Propose a minimum of 10 buildable lots / units or a minimum of 3 infill units

Grant covers one-third of the total cost of eligible items up to \$500,000

Available in 2022 & 2023 on a first come first served basis

# Progress: Early Education, Public Health Response

#### Education

- · Budget for Projects: \$1.1 M
- · Currently scoping projects with two early education providers
- · Aligning scope of work with ARPA grant reporting requirements have proven difficult

#### Public Health Response

- · Budget for Projects: \$1 M
- · Currently scoping projects with three entities
- Procurement process/regulations are currently being worked through to ensure that these projects are fundable

The specifics of these projects will be announced once the scopes are approved by the Commissioners at a future public meeting

# Progress: Revenue Loss, Workforce Development

#### Revenue Loss

- Budget for Projects: \$750,000
- Became a catchall category for applicants whose projects weren't able to be funded after the final rule guidance was published
- Minimum Grant: \$5,000 Maximum Grant: \$50,000
- · Awarded/reviewed grant requests for 11 non-profits
- · Awarded/reviewed grant requests for 16 for-profits


#### Workforce Development

- · Budget for Projects: \$200,000
- Became a hybrid category with a housing component in partnership with Habitat for Humanity
- Scopes generally focus on building high efficiency housing in Williamsport and So. Williamsport
- · Partnership with Penn College will give students hands on experience with construction







#### RESOLUTION REGARDING THE PURCHASE OF REAL ESTATE

WHEREAS, the Pennsylvania College of Technology (the "College") is the owner of certain real Properties located at 1359 W. Third Street, Williamsport, Lycoming County, Pennsylvania, known as Lycoming County Tax Parcel Number 70-015-203 and 3341 Wahoo Drive, Williamsport, Lycoming County Pennsylvania, known as Lycoming County Tax Parcel Number 67-026-400.E and Vacant Land located on Fritz Station Road, Brady Township, Lycoming County Pennsylvania, known as Lycoming County Tax Parcel Numbers 04-431-101.A and 04-431-405 (hereinafter the "Properties"); and

WHEREAS, the County determined that it was in its best interest to purchase the Properties; and

WHEREAS, the County has undertaken all steps required under the County Code to purchase the Properties; and

WHEREAS, the Parties have since entered into an Agreement of Sale memorializing the terms and conditions of the purchase of the Properties as outlined in the Agreement of Sale for the collective purchase price of One Million Three Hundred Eighty-Three Thousand Dollars (\$1,383,000.00) ("Agreement of Sale");

WHEREAS, the Agreement of Sale was approved by the Board of County Commissioners at the regularly scheduled meeting on July 20, 2023;

WHEREAS, the purpose of this Resolution is to confirm the authorization by the Board of County Commissioners to permit closing documents related to the transaction to be signed by Matthew A. McDermott, Director of Administration and Chief Clerk;

NOW, THEREFORE, be it resolved by the County of Lycoming, at a duly advertised public meeting and following public comment, as follows:

- On July 20, 2023, the County agreed to purchase the Properties pursuant to the terms of the Agreement of Sale between the County and the College.
- The County hereby authorizes Matthew A. McDermott, Director of Administration and Chief Clerk, or any other agent deemed appropriate and so designated by the

Board of Commissioners, to execute on behalf of the County any and all documents necessary to effectuate the transactions contemplated by the Agreement of Sale.

 The County hereby ratifies and confirms all other actions taken by the County or its agents in regards to the purchase of the Properties.

THIS RESOLUTION is duly adopted by unanimous vote this Alst day of Commissioners at its duly noticed public meeting.
