Chuck Kiessling, Coroner commented that this is the first step in the process. The Architects are familiar with the design needed as they have built Coroner facilities in other counties.

Mr. Mirabito explained to the public that this is a services contract which does not need to be put out to bid. This is a specialty project. These architects have the expertise that's necessary to build a proper coroner's facility. Also, the fee was very reasonable and the cost is part of the overall project. Mr. Mirabito stated that there is a need to get the Coroner and his staff in the building as quickly as possible.

9.2 Matthew McDermott for Mya Toon – Vote to approve FY 2023-2024 Juvenile Probation Services Grant Agreement in the amount of \$242,417.00 (2023 budgeted item).

Mr. Mirabito moved to approve. Mr. Mussare 2nd the motion. Approved 3-0

10.0 COMMISSIONER COMMENT

Mr. Mirabito commented about the current childcare crisis with the YMCA childcare facility being shut down. He reported that the Commissioners have appropriated \$1,000,000.00 to Early Learning. They have been approached with a proposal from STEP and one from Fire Tree place for consideration. Per Mr. Mirabito child care centers have difficulty keeping staff due to the low pay and the state certifications workers need. Many centers have closed due to this. He pointed out that this is a crisis for our community. People without childcare aren't able to work and will lose their job. Many are single parents. The lack of available childcare has the potential to prevent people from moving into the area. He reviewed ideas to assist with the problem as well as possible funding streams. Mr. Mirabito believes that we have the ability to respond to this crisis and begin to build this needed capacity.

Mr. Mussare commented on the need for the Federal Government to help with this crisis and the need to find solutions. He commented on the Federal Governments spending and priorities.

Mr. Metzger responded that there are two issues that need to be addressed: affordable childcare for families and increased wages for childcare workers so they can make a living wage. Currently they make less than working in a fast food restaurant. Theses two issues must be addressed first.

Mr. Metzger announced that he had volunteered to pack food at the food bank and commented on his experience. He encouraged everyone to volunteer to help or donate to any of the food banks in the area. He provided the following statistics: 1 out of every 8 adults and 1 out of every 5 children are food deficient in this county.

Mr. Metzger reminded everyone about the 911 ride through the community in honor of all those who lost their lives. He thanked all those who make it happen as well as the riders. We are honored and blessed to have this in our community.

11.0 GENERAL PUBLIC COMMENT

Speakers who wish to address the Board of Commissioners will be limited for <u>no more than three (3) minutes</u> on any particular item. The speaker must state his/her name and address for the record. Any deviation from this rule must be approved by the Board Chairman.

Tom Schaeck, Pennsdale, Muncy Twp., Mr. Schaeck informed everyone that he sent a letter representing himself and 17 people in Muncy Township to the Lycoming County Board of Elections regarding concerns about the actions of an Election Judge in the Pennsdale precinct. The concerns were regarding a potential violation of Act 69 of 1933 passed by the PA Legislature regarding the holding of multiple offices by an election judge. Mr. Schaeck reported that he has not received any answer to date and finds this

unacceptable. He and the others he represents believe there are actions which need to be addressed. Mr. Schaeck also expressed his views on the Early Learning crisis. In his opinion we need skillful, maintainable good paying jobs to get young people to stay here and draw others to relocate here.

Tom Adams, Williamsport. Mr. Adams expressed his views on communication and the power of the tongue. He also voiced his opinion on moving the election and the escaped prisoner in Philadelphia.

Sheriff Mark Lusk – Sheriff Lusk explained that Department Heads and Elected officials try to generate revenue as much as possible. The Sheriff's Department is beginning to receive reimbursements from the state for Deputy trainings that were due several years ago. Sheriff Lusk explained the move of the Domestic Relations files and the changes in space for the Sheriff's Department. The changes allow Domestic Relations they need for the files while at the same time gives the Sheriff's Department the room to expand to accommodate his staff. Sheriff Lusk clarified that the Sheriff's Department operational issues were not a Sheriffs sale issue as indicated on social media.

Ms. Stephanie Tribble, Director Domestic Relations, reported that the file room is where all the official files are kept. The expansion allows them to maintain space for files in the future. The cost is covered by incentive money the department has been awarded and will not cost the taxpayers any money.
