Coach Jacobson emphasized that every high school athlete aspires to win a State Championship title. He reflected on the teams struggles over the recent years and highlighted the ambition and dedication of the team that led them to victory this year. Mr. Jacobson stated that the team earned every second of the recent win and highlighted the State player of the year Alaina Dadzie.

The members of the Loyalsock girls' basketball team each stood up and introduced themselves stating their names and their current academic year.

The Loyalsock team coaches and administrators each stood to introduce themselves and offered words of encouragement and congratulations to the Loyalsock girls basketball team for their achievement.

Commissioner Sortman congratulated the Loyalsock girls' basketball team for becoming the first female team from Lycoming County to win a State Championship, noting that this historic accomplishment will be a memorable part of their lives. Commissioner Mussina remarked on the challenges that smaller schools face in competing against private schools, emphasizing that the team's victory was especially impressive given these obstacles. Commissioner Mussina praised the team's resilience and acknowledged the behind-the-scenes struggles in sports, noting that the audience might not always see their efforts. Commissioner Mussina highlighted the significance of each player's contribution, regardless of their role and praised the coaches stating they are among the best in District 4.

Commissioner Metzger praised the Loyalsock girls' basketball coaches for their dedication and care for their players. Commissioner Metzger discussed how high school sports foster community spirit and bring people of all ages together as the team advances. Commissioner Metzger noted that the team serves as role models for young girls, emphasizing their support for one another and the importance of each player's role in creating a successful team. Commissioner Metzger recognized the team's achievement stating it's a milestone they can cherish for years to come.


