Controller Krista Rogers called the meeting of the Lycoming County Retirement Board to order at 11:46 a.m. Thursday, August 8, 2024 in the Commissioners' Board Room, third floor, Third Street Plaza. Board members present included: Commissioner Scott Metzger, Commissioner Mark Mussina, Controller Krista Rogers, and Treasurer Cindy Newcomer. Also in attendance was Solicitor Christopher Kenyon, Seth Lynn from Dahab Associates, Paul Baugher from Foster & Foster Actuaries, Deputy Controller Nicki Gottschall, Senior HR Business Partner Michael Hagen, Chief Budget Office Heather Lehman and Jennifer Brown (Administrative Support Staff from the Controller's office).

Commissioner Metzger made a motion to accept the May 16, 2024 meeting minutes. Treasurer Newcomer seconded the motion and it passed unanimously.

Commissioner Metzger made a motion to accept the 1<sup>st</sup> quarter 2024 invoice from Dahab in the amount of \$ 17,845.00. Commissioner Mussina seconded the motion and it passed unanimously.

Treasurer Newcomer made a motion to accept the 2<sup>nd</sup> quarter 2024 invoice from Foster & Foster in the amount of \$7,250.00. Commissioner Metzger seconded the motion and it passed unanimously.

Seth Lynn from Dahab Associates presented the 2<sup>nd</sup> quarter 2024 performance report for the Retirement Fund. Commissioner Mussina made a motion to accept the report as presented. Commissioner Metzger seconded the motion and it passed unanimously.

Foster & Foster Actuaries gave a presentation regarding the Actuarial Valuation and a cost of living adjustment for retirees for 2025. We will revisit the cost of living adjustment at November's Retirement Board Meeting.

A brief discussion was had regarding the increase in ADEC (Actuarially Determined Employer Contribution). The 2024 ADEC estimate provided by Municipal Finance Partners was \$ 332,601.00. The Commissioners budgeted \$ 400,000.00 for the 2024 ADEC. The actual ADEC for 2024 is \$ 1,169,792.00. The office of Financial Management is going to explore ways to pay the 2024 ADEC shortfall of \$ 1,129,792.00.

Retirement Board reporting was presented from May 10, 2024 through August 1, 2024. Treasurer Newcomer made a motion to accept the report as presented. Commissioner Metzger seconded the motion and it passed unanimously.
