Commissioner Mussare made a motion to accept the Experience Study Proposal by our Actuary, Chuck Friedlander from Municipal Finance Partners. Treasurer Newcomer seconded the motion and it passed unanimously.

Controller Rogers made a motion for the Retirement Board to review the necessity of an Experience Study every four years. Commissioner Mirabito seconded the motion and it passed unanimously.

Commissioner Mirabito made a motion to have the Retirement Board make a recommendation to the Board of Commissioners to make monthly ADEC (Actuarially Determined Employer Contribution) payments into the retirement fund. Controller Rogers seconded the motion. Commissioner Metzger and Treasurer Newcomer voted in favor. Commissioner Mussare opposed the motion. Motion passes.

Seth Lynn from Dahab Associates presented the  $1^{\rm st}$  and  $2^{\rm nd}$  quarter 2020 performance report for the Retirement Fund. Controller Rogers made a motion to accept the report as presented. Commissioner Metzger seconded the motion and it passed unanimously.

The meeting was adjourned by Deputy Controller Gottschall at 11:25 a.m.
