INSTRUCTIONS FOR MOTION FOR CHANGE OF VENUE

- 1. Complete the motion form, per the included instructions.
- 2. Complete the motion cover sheet form, per the included instructions.
- 3. Complete the proposed order form (caption only), per the included instructions.
- 4. Arrange the three forms in order, motion cover sheet first, then proposed order, then motion.
- 5. Make copies one for each party involved in the case.

6. Take the original motion with proposed order and cover sheet and the copies to the Prothonotary's office for filing at the Lycoming County Courthouse, 48 West Third Street, Williamsport, PA. There is no filing fee for this petition.

7. The Prothonotary will keep the original and the copies and you will then receive back in the mail from the court either an Order transferring the case and directing you to pay the costs of transfer (which as of August 1, 2021 are \$26.50), or an order scheduling the matter for a hearing. Even if the parties agree, the court may still hold a hearing to determine whether the transfer is appropriate. Each case is decided based on the facts of that case and the custody jurisdiction laws, and not necessarily based on the parties' agreement.

8. If the motion is granted and you are directed to pay the costs of transfer, you must go to the Prothonotary's office and make the payment before they will transfer the case (unless you are granted a fee waiver; there is a separate self-help kit for making this request, available online or in the Law Library). The county where the case is transferred to may also ask for a filing fee; this is up to each individual county.

INSTRUCTIONS FOR COMPLETING MOTION FOR CHANGE OF VENUE

1. Write the Plaintiff's name, Defendant's name and the docket number exactly as they appear on your custody order.

2. In Paragraph 1, write your name on the blank line after the word Petitioner" and write your address where indicated.

3. In Paragraph 2, write the date of your current custody order on the first blank line and on the other two blank lines, write the terms of the order respecting physical custody of the children. For example, "Mother has primary physical custody of the children and Father has partial physical custody on alternating weekends" or "the grandmother has physical custody of the child and parents have partial custody on alternating weekends".

4. In Paragraph 3, on the first blank line write the county where the children currently live, on the second blank line write the person(s) they live with, and on the third blank line write the date they started living there.

5. In Paragraph 4, write the type of pleading you wish to file after the matter is transferred. For example, "petition for modification" or "petition for contempt".

6. In Paragraph 5, circle the word "consents" or the words "does not consent" to indicate whether the other party agrees with the request for the transfer of venue. If the other party consents, ask that party to complete and sign the consent provision at the end of the petition. By showing an agreement, you may avoid having to come into court to make your request.

7. In the "wherefore" clause, write the name of the county you wish to transfer the case to.

8. Sign where indicated, then read the "Verification" language and sign where indicated. Write in your name and address after your signature.
