- 3. Get Order allowing service by publication and waiving the requirement of service of the Section 3301(d) Affidavit and the Notice of Intention to Request Decree.
- 5. Wait twenty days from date of publication.
- 6. File Notice of Intention to Request Entry of Decree with blank Counter-Affidavit (Form 9).
- 7. Wait twenty days.
- 8. File Praecipe to Transmit Record (Form 12) and proposed decree (Form 13), include one self-addressed (to you) envelope. (On Praecipe, date of service of complaint (line 2(a)) is date of publication, manner of service (line 2(b)) is "publication", manner of service of Affidavit (line 3(b)(2)) is "waived" and Notice of Intention, date served and manner of service (lines 5(a)(1) and (2)) are both "waived".)
