The Department of Environmental Protection (DEP) has received and reviewed the August 28, 2024 document titled "Act 2 Remedial Investigation Report/Cleanup Plan" (report), for the property referenced above. The report was prepared by BAI Group and submitted to the DEP in accordance with the Land Recycling and Environmental Remediation Standards Act (Act 2).

The DEP hereby approves this report for the substances identified and remediated to an Act 2 standard within the sites specified. Chapter 5, Section 501 of Act 2, provides the liability protection where attainment of Act 2 cleanup standards is demonstrated. The cleanup liability protection provided by this chapter applies to the current and future owner or any other person who participated in the remediation; a person who develops or occupies the property; successor or assign of any person to whom liability protection applies; and a public utility to the extent the public utility performs activities on the identified property.

This project attained a Site-specific Standard for soil impacted by the following compounds: lead, arsenic, selenium, mercury, silver, barium, cadmium, 22 organochlorine pesticides by the Environmental Protection Agency's (EPA) method 3541, 7 polychlorinated biphenyls (PCBs) by EPA method 3541, 72 semi-volatile organic compounds (SVOCs) by EPA Extraction Method 3541 and 62 volatile organic compounds (VOCs) by EPA method 8260 B.

Please refer to the enclosed Standard Attachment for other DEP program requirements for considerations which may be applicable to the referenced site.

Any person aggrieved by this action may appeal the action to the Environmental Hearing Board (Board) pursuant to Section 4 of the Environmental Hearing Board Act, 35 P.S. § 7514, and the

Administrative Agency Law, 2 Pa.C.S. Chapter 5A. The Board's address is:
