WHEREAS, the current Review Fees have not increased since 2009, and

WHEREAS, due to increased costs an adjustment of the fee schedule is warranted at this time.

NOW THEREFORE, BE IT RESOLVED that:

Effective January 1st, 2021, the following Review Fee Schedule shall be implemented:

Zoning Permit-No Site Plan Required- (examples: single family residential modular, duplex, or manufactured homes, conventional and seasonal homes, single family residential <u>uses</u> including, additions of less than 2000 sq. ft., un-enclosed decks or porches attached to residence, deck and porch enclosures, kennels, commercial stables, or additions of less than 2000 sq. ft. to commercial, institutional, or industrial buildings)

Temporary Permit (examples: logging, temporary sign, emergembile home, special event, produce or farm stand, Xmas trees shed or trailer, real estate sales office, concrete/asphalt batch drilling; temporary water withdrawal sites)	e sales, contractor office, construction equipment n plant, borrow pit, mobile sawmill, oil and gas
