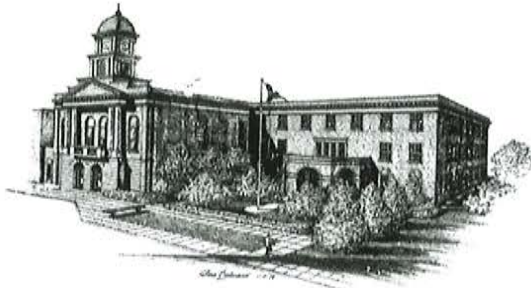



- a. Further Attendees Required - AH reiterates the need for all represented groups to be present, says that DEP told us to be more aggressive in finding municipalities to join the SWAC; requests Counties to call their municipalities to request involvement. SR says again that draft reviews need a full committee.
- b. CO&A request AH says CO&A alteration request was formally submitted with a deadline date of 3/1/24. AH and SR agree that DEP have a positive view of that deadline. SR says Counties will need to sign an adoption of the final alteration, GM asks if that will need to be done one county after the other. SR says no, that was a plan adoption.
- c. MOU update AH says that the previous plan adoption delays due to successive execution informed the new MOU drafted; Counties can put through the adoption process simultaneously. AH says MOU is going through internal review now, should be ready to get to Counties in a week or two. AH says that complete adoption is to be accomplished by the end of the year. AH says MOU will specify amounts to be invoiced to the Counties for their cash match contribution, once at MOU adoption and again in a year's time. GM asks what the amount will be for Commissioner's consideration, SR says it will remain the same as what the initial MOU and grant outlines.
- d. Staff Transition AH says SR will be the POC ongoing through to Plan adoption. AH says quarterly reports to DEP and municipalities will be quarterly instead of monthly, as only two Counties sent us record of municipal notification from last meeting.

2. Data Needs

a. Recycling Rates - AH says that getting recycling rates from the Counties is the most important thing to accomplish now because so many chapters yet to be drafted require that data. As of now, non-Act 101 recycling rates are needed from Lycoming and Union, all recycling rates are needed from Montour, residential is needed from Snyder. LS asks what categories of non-Act 101 materials specifically, AH says only whatever categories all Counties are capable of reporting for the sake of consistency. SR disagrees, and says that Counties should send us all the recycling data that they have to improve our overall recycling rate. SM requests clarification that AH means tons by 'recycling rates', that is confirmed. SR asks counties to provide yard and leaf waste data, SL says they have a few municipalities that report it, AH says some of that reported data has been sent with non-Act 101 rates.

b. Special Collection Events - AH says that a few Counties mentioned future special collections planned, the details of which did not get sent to her, and requests all info on special collections. SR adds that it is important to include special collection plan obstacles, and what has overcome obstacles, like working with law enforcement to ensure recycling drop off sites are not sites of illegal dumping. BH says that Union found surveillance footage helped that.

c. Recycling Drop Off Locations - AH requests Counties also provide information on the locations of their recycling drop off locations, both for mapping purposes and to provide enough information to justify listing drop off locations in the appendix instead of body. SR and LS reiterate a desire to put drop off locations in the appendix.

3. Overview of Plan Progress AH goes over what plan chapters have been drafted, what need to finish drafting, and what can only be finished upon plan completion. AH asks Counties if that outline would be helpful, or if basic information requests are better. GM says basic information requests, specifically what Lycoming needs. AH says that she will tailor emails with requests to the Counties based on what they have already provided. SR asks if anyone would want Lycoming GIS services, SM and GM say Columbia does Snyder and Montour's GIS work. BH says that DEP provides recycling data, and that he has just been forwarding that. AH says that she has only been able to find <2020 data via DEP websites, and could she get the link that BH uses. BH says that the data is passcode protected; LS says that recycling coordinators only get access to their own County data, so that might not be feasible to do by Lycoming for all Regional data.

Shannon Rossman and Alexa Bixel will be sending the 1st Quarter reports out at the end of next week. Those reports will touch on a few items from last year. Documentation of those reports being sent out to municipalities is required. Shannon Rossman asked if reports are emailed or sent paper copy that her and Alexa Bixel be copied on those letters/emails to provide backup documentation to be added to the appendix section of the plan.
- c. CO&A request – still waiting – Still waiting to hear back from the state on a revised CO&A request. Original request was sent October 31st, 2022. The request letter was acknowledged to have been received November 1st, 2022 to extend the deadline of the plan requirement till March 1st, 2024. In January, Shannon Rossman talked to DEP and it appears that the request was misplaced. Shannon Rossman reached out last week to DEP and has not received an answer as to when the revised CO&A will be sent out. Shannon Rossman will be following up weekly on this item is resolved. Work on the Plan will continue despite this occurrence.
- d. MOU update – Draft Complete – Draft MOU is complete for all counties. As soon as purchasing agrees the draft will be sent out to the committee for review and signature. MOU

includes information about the joint plan and will have the plan ready for adoption and completion on March 1st, 2024. The first plan contribution invoice for each county will be included with MOU. Second plan contribution invoice will be due during final draft phase of the plan.

- e. Staff Transition – Natural Resource Planner, Alexa Bixel – introduced new natural resource planner to committee. Alexa started in February. She is recent graduate from Lock Haven University with a Bachelor's of Science in Environmental Biology with a concentration in Ecology and minor in Environmental Science. She will be helping with the coordinating of the Solid Waste Plan.

3. Data Needs/Mapping

- a. Recycling Rates – received – All recycling rates from all the counties have been received. Currently in the process to incorporate all of them into the plan. Shannon Rossman noted that as soon as that portion is completed it will be sent out verification.
- b. Special Collection
 - i. Events & locations – still confirming information – Shannon Rossman noted special collection information is still being verified.
- c. Recycling Drop Off Locations – in progress – Shannon Rossman noted the receiving facilities map has been updated with new additional information. The committee received of that for review.

4. Overview of Plan Progress

- a. Chapters 1-3 are in draft format – Draft format will be send of chapters 1-2 will be sent out for comment. As edits take place, the draft will be sent out and comments/edits will be added to document. Edits can be tracked in the document. Shannon Rossman commented committee members should feel free to send changes, comments, or questions to send those back to be addressed. Shannon Rossman emphasized the importance of getting all counties valuable thoughts into the plan. Committee members should expect a similar format for other chapters.
- b. Meetings with Counties to verify information and content – To satisfy Act 101 requirements it is key when updates are sent out that PCD receives verification that municipalities have made aware of those updates. As DEP is mostly concerned with committee, attendance and municipalities are being notified of updates. Shannon Rossman noted that if any further issues arise with DEP, She might include committee members on emails in the future to make everyone aware of any current issues.

- 5. Questions – Greg Molter asked if there was any grant money associated with this plan for appropriation for doing the rewrite. Shannon Rossman replied by saying there is a grant from the state to do the work that will cover our staff time. That will be matched with our staff time and each counties cash contributions. Greg Molter mentioned that he asked this question because when the process was initially started for the first regional solid waste plan there was a very large sum that had be either spent down at the end or divided between the counties to put into some kind of an event. He wondered if there was another opportunity over covering half of the staff time to draw money from Harrisburg to make this happen. Shannon Rossman replied to say we are fine with

matching the time and each counties cash match would be \$2,344.75. That is each counties contribution to the plan for the update being done. She also says there are no concern with covering our costs for this update. Rachel Swartwood added that if an attachment is sent to her email that she would like back up email sent to her to confirm the attachment reached her email. Shannon Rossman replied that would not be an issue that she would follow up with an email after sending the draft out.

6. Next Meeting – April 19, 2023 at RMS (Lycoming County Landfill) – Shannon Rossman noted next month's Committee meeting would take place in person at the Lycoming County Landfill. Lunch to be provided to attendees with a tour of the facilities and meeting afterwards. Maps of different items included in the plan will available for review and input. Shannon Rossman confirmed most committees members could attend. GIS attendee will be at the meeting to address any mapping questions.

1. Administration

- a. MOU update – Shannon Rossman made note that everyone has signed their CO&A. The MOU will be sent out for all the counties to sign.
- b. Reports – Shannon Rossman send out the quarterly report to all counties to relay to their municipalities. Shannon Rossman mentioned for the counties to send back their confirmation of the report being sent out back to us to file.

2. Data Needs/Mapping

- a. 2021 Data just released – Shannon Rossman mentioned that last week the 2021 Data from DEP on recycling has been released. Shannon Rossman said that our plan would be use the data as a reference, instead of changing our current information in the plan. As She would like to use this information to further support the claim that our recycling rates are doing well. Shannon Rossman suggested the addition of paragraph and table to include the new 2021 information. Shannon Rossman does not want to change graphs at this time since Alexa Bixel has been updating them. Shannon Rossman made note that most of the charts and graphs have updated to look nicer and changed to bar graphs.
- b. Changes to Maps? – No Changes to the Maps were suggested at this meeting.
- c. Special Collection
 - i. Events & locations past examples – Shannon Rossman stated she would like to receive pictures and flyers of any special collection events or past events to include in the plan. Shannon Rossman made mention Alexa Bixel has working on compiling them for the plan.
 - ii. Future Events – Shannon Rossman made mention that Future Events would be good include the plan as well. It was encouraged for the counties to send pictures or flyers to be included in the plan as well.

3. Overview of Plan Progress

- a. Budgets
 - i. Recycling Budget Information – Shannon Rossman stated that Recycling Budget information is important to include in Plan. As data is relevant to address costs raising in the region. Shannon Rossman would like to stress this idea in the plan

and changes that have occurred over the last few years with the covered device recycling act. Shannon Rossman mentioned that so far the only recycling budget received was from Union County. Shannon Rossman urged the counties to respond to this request.

- b. **SOI** – Shannon Rossman made note that Alexa Bixel was trying to collect information on the different rates for Landfills to include in the plan. As it was realized that some information that was given was a mix of commercial and residential rates. Currently, Shannon Rossman and Alexa Bixel are going through and identifying these rates to confirm information.
- c. **Permitting Haulers** – Shannon Rossman brought up that Shawn McLaughlin made a good point looking towards permitting haulers. As it had not been previously discussed in meetings. Shannon Rossman stated that for this plan it is not proposed to permit haulers. As there is no reason at this time to permit haulers since haulers are already permitted through DEP. Greg Molter mentioned that he agreed with not permitting haulers. As when Montour permitted haulers, it ended up in a legal battle. Michael Hnatin seconded in agreement to not permitting haulers, as he did not see any gain in it. Shannon Rossman noted the only time she saw gain from permitting haulers was in mandatory trash collections at the municipal level. Mandatory trash collection is not foreseen in the future for the region at the County level. Shawn McLaughlin made mention at time it was standard to have mandatory collection for flow control, however, due to DEP regulations this changed and somewhat halted counties ability to mandate.
- d. **Working Draft under review by Stakeholders**
 - i. **Comments received from Union County and Bloomsburg Borough** – Shannon Rossman stated she has only received comments from Union County and Bloomsburg Town.
 - ii. **Additional comments?** – Shannon Rossman noted she still needed comments from Montour, Colombia and Snyder. Shannon Rossman strongly suggested for the counties to make mention of anything they saw they would like changed in the plan or did not agree with. Shannon Rossman made the note that there are still some items that need to be placed into the plan. Shannon Rossman will primarily focus on updating the summary for the plan. In this section, she would like to highlight plans, growth, and ideas. Shannon Rossman also wants to include any county issues in this section and stress the importance of costs raising.

- b. Invoice – Shannon Rossman made the other 4 counties aware that invoices will be sent out shortly since all signed MOU's have been received.
- c. Municipal Email verifications – Shannon Rossman noted that counties need to be sending in their Municipal Email verifications over to Lycoming County. As the inclusion of this verifications is crucial for the plan. Alexa Bixel will be reviewing the sent email verifications and reaching out to the counties who have not sent their in.

2. Preliminary Draft

- a. Questions – Shannon Rossman asked if any of the other counties had received any questions on the preliminary draft. The other counties mentioned had not received any questions regarding the plan.
- b. Comments – public/stakeholders/steering committee – Shannon Rossman continued with the meeting by asking if any of the other counties had received any comments on the preliminary draft. The other counties mentioned they have not received anymore comments regarding the plan.

3. Submittal of Draft to DEP

- a. Verified received via email – Thursday October 26, 2023
- b. Paper copied delivered Friday October 27th
- c. Plan Preliminary Review with DEP – Wednesday, January 17th, 2023 – Shannon Rossman mentioned to the group that her and Alexa Bixel had a brief meeting with DEP this morning to go over the first initial comments from the preliminary review. Shannon Rossman went to say that the person who is reviewing the planning had a family emergency and could not attend this first initial meeting. A follow up meeting will be schedule to go over their

comments at a later date. Shannon Rossman said that her and Alexa Bixel met with Joe Delgrippe, Mark Vottero, and Jason Yufer to discuss a few things regarding the plan. Shannon Rossman continued to say that one of their concerns were that the counties did not get a lot of participation from business/industry entities to be on the committee. Shannon Rossman asked that if counties had any documentation regarding reaching out to business/industry entities to participate on the committee that they send Lycoming County documentation of that to include in the plan. Shannon Rossman discussed the second concern of the counties promoting the plan as an open one without flow control and therefore will need to do a couple a minor thing to ensure fairness among facilities. Shannon Rossman said in order to do so, Her and Alexa Bixel will be reaching out to the landfills included in the plan and give them the opportunity to comment on the plan. Shannon Rossman also noted that a listing of facilities will also be included in the plan besides just referencing. Shannon Rossman also said that the flow control ordinances will be removed from the plan. Shannon Rossman went to explain that if our plan is an open one, the removal of the flow control ordinances would make sense. Shannon Rossman then moved on the third concern of municipalities discontinuing their drop-off locations for recycling. Shannon Rossman noted that the discontinuing of a drop-off location would result in a major revision to the plan and if any municipalities used a 902 grant to purchased equipment for that location they would need to pay back to the department. Shannon Rossman explained that the movement of drop-off locations within in the area were not considered a major revision. Shannon Rossman went to say that DEP offered to have meeting with the counties to further discuss drop off locations, the issues that these sites are experiencing and offer assistance. Shannon Rossman made the counties aware that 902 grants will be opening again in the spring with 20 million dollars being available. Shannon Rossman counted on to say that Lancaster County Solid Waste Authority is putting together a lithium battery education and program for other counties to use. She noted that the educational materials could be tailored for other counties to use, would free of cost, and also are expected to be available later this year. Lauren Strassuer mentioned that Lycoming County would also be accepting lithium batteries next month and that Lowes and Staples also accept batteries. Shannon Rossman also mentioned that Best Buy could be an outline for recycling covered devices. However, Best Buy in the region has closed, but there is a Best Buy located in Snyder. Alexa Bixel will be reaching out to Best Buy to find out about what items Best Buy will recycling and the cost. Shannon Rossman finished the discussion by mentioning the three main concerns of committee participation, flow control ordinances and discontinuing of drop off locations.

4. Next Steps

Shannon Rossman concluded the meeting by making mention of the availability of 901 grants to counties for education and household hazardous waste.
