WILLIAMSPORT AREA TRANSPORTATION STUDY COORDINATING COMMITTEE TELECONFERENCE PUBLIC MEETING MINUTES

January 25, 2021 Coordinating Committee Teleconference Public Meeting: Held at various locations via teleconference.

CALL TO ORDER (Regular WATS Coordinating Committee Teleconference Public Meeting)

Chairperson Tosca called the meeting to order at 1:00 P.M.

INTRODUCTIONS/ROLL CALL

MINUTES

November 9, 2020 Coordinating Committee Public Meeting

Chairperson Tosca called for a motion to approve the November 9, 2020 Coordinating Committee meeting minutes. Carey Mullins motioned for approval of the meeting minutes, Commissioner Mirabito seconded, minutes unanimously approved.

PUBLIC COMMENT

There was no public comment.

ACTION ITEMS

TIP Amendment (Reaffirm e-Ballot)

Scott Williams presented the Transportation Improvement Program (TIP) Amendment e-Ballot reaffirmation and the request that the Coordinating Committee reaffirm the e-Ballot. Scott reminded the Coordinating Committee that they were emailed in December 2020 to vote via e-Ballot to recommend approval of a TIP Amendment on the 2021-2024 WATS TIP to change the funding source of the construction phase of MPMS 99038 to Federal funding. The project is a bridge improvement on State Route 2014 Lycoming Mall Drive over Bennett's Run in Fairfield Twp.

Scott informed the Committee that the WATS Technical Committee reaffirmed their e-ballot vote at their January 11, 2021 meeting and now the Coordinating Committee, per the WATS Bylaws, needs to reaffirm their e-ballot vote.

Chairperson Tosca called for a motion for the Coordinating Committee to reaffirm their TIP Amendment e-ballot vote. Commissioner Mirabito motioned for the approval, Jeff Stover seconded the motion and the motion unanimously passed.

WATS Bylaws Amendments

Scott Williams presented the draft WATS Bylaws Amendment. Scott reminded the Coordinating Committee that the Lycoming – Sullivan Boroughs Association has dissolved. Per the WATS Bylaws, the Boroughs Association was a member of the Coordinating Committee. Since that organization no longer exists WATS must create another approach to maintain representation on the Coordinating Committee for the nine (9) Boroughs in Lycoming County. Scott informed the Committee that the Lycoming County Township Supervisors Association and the City of Williamsport both have representation on the WATS Coordinating Committee.

Scott presented the proposed solution to the Coordinating Committee whereby, every two (2) years the WATS Secretary (PCD Transportation Supervisor) will contact all nine (9) Lycoming County Boroughs to gauge their interest in participating on the Coordinating Committee. Once a Borough(s) have confirmed their interest, the WATS Secretary will present the interested Borough(s) and a recommendation to the Technical Committee. The nominated Borough will then be presented to the Coordinating Committee for approval to represent the interest of all Lycoming County Boroughs and serve on the WATS Coordinating Committee. Scott pointed out that it is of the upmost importance that the selected Borough realize they are representing the interest of ALL Lycoming County boroughs for their two (2) year term. Scott also stated that the Bylaw Amendment language was constructed so that, if the nominating and approval process is delayed the current Borough will continue to serve as the representative until a new nomination and approval is finalized.

Scott informed the Committee that the first Borough representative would serve a shortened term, being the remainder of 2021 and the entire term of 2022. The reason for the shortened term is to ensure consistency with the WATS TIP and UPWP update cycles. The second Borough appointment will be the last public meeting of 2022. Also, Scott informed the Committee that the goal is to have a Borough nominee for Committee consideration at the next Coordinating Committee on May 10, 2021.

Scott also informed the Committee that the Bylaws Amendment formalizes the process whereby the Technical and Coordinating Committees set their meeting schedules in the upcoming calendar year at their last meeting of the year. Scott informed the Committee that both the Technical and Coordinating Committees have been using this process in practice, but having the process formally recognized in the WATS Bylaws is more transparent.

Scott stated that the other major change in the Bylaws, Section III Article IV, which states that a majority vote of the Coordinating Committee, is sufficient to change/alter the membership of any WATS MPO committee. This language was not in the previous WATS MPO Bylaws; however, it is important to have the language in the MPO Bylaws if/when the MPO changes or alters the composition of the committees. Scott also informed the Committee that there is new language clarifying that the Committee Chairs do count for the purposes of establishing a quorum for MPO meetings.

Commissioner Mirabito asked what the process is if 2-3 Boroughs are interested in serving on the Coordinating Committee. Scott stated that part of the selection process would be speaking with all of the interested Boroughs to determine which Borough is the best choice. Commissioner Mirabito asked if the Bylaws needed to specify the selection process language. Scott stated that as part of the process the WATS MPO Secretary will make a recommendation on which Borough to move forward for a nomination.

Mark Murawski stated that the Boroughs do not have a single organization so the MPO suggested this process to allow all Boroughs an opportunity to show interest and serve on the Committee. Mark asked if a Borough's term expires if they can be reappointed as the Borough representative. Scott stated that in the Bylaw amendments the process is set up so that a Borough cannot serve for consecutive terms, unless there is no interest from any other Borough at the time of appointment.

Chairperson Tosca called for a motion for the Coordinating Committee to approve the WATS MPO Bylaw Amendments. Commissioner Mirabito motioned for the approval, Councilmember David Banks seconded the motion and the motion unanimously passed.

PM-1, PM-2, and PM-3 Performance Measure (PM) Targets for 2021

Scott Williams stated that this item is for the Coordinating Committee to authorize the WATS Secretary (Scott) to sign and return the WATS MPO Performance Measure documentation for 2021. Scott explained that there are three (3) performance measures, PM-1 Safety Measures, PM-2 System Condition Measures, and PM-3 System Reliability Measures. These PM's apply to PennDOT statewide. Scott informed the Committee that as an MPO we can support the PennDOT statewide targets by incorporating them into the MPO planning and programming, which is what the MPO has currently been doing, or the MPO could set up our own more stringent targets. However, if the MPO sets up our own targets, then the MPO would be responsible for implementing and tracking those measures. Scott recommended to the Committee that the MPO continue to support the statewide PM targets. Scott requested that the Coordinating Committee authorize the WATS MPO Secretary to sign and return the Performance Measure documentation for 2021.

Chairperson Tosca called for a motion for the Coordinating Committee to authorize the WATS Secretary to sign and return the PM-1, PM-2, and PM-3 Performance Measure Targets for 2021. Commissioner Mirabito motioned for the approval, Carey Mullins seconded the motion and the motion unanimously passed.

DISCUSSION ITEMS

Management Action Report

Chris King presented information on management action items. Chris informed the Committee that the Management Action Items can be found at the end of the WATS MPO Coordinating Committee packet. Chris stated that there are a number of embankment failures in Lycoming County and that many of the Action Items were funding the preconstruction phases (design, Right Of Way, utilities, etc.) of the repairs. There is also a local bridge construction funding increase and funding for design phases for some projects (traffic signal in Muncy Borough, etc.)

Act 106 (Personal Delivery Devices)

Scott Williams presented information on Act 106 Personal Delivery Devices (PPDs). Act 106 was approved by the State Legislature in 2020 and will become effective on January 30, 2021. Scott informed the Committee that PDDs are essentially delivery robots and Act 106 sets limits on the size and weight of the PDDs. Scott stated that Act 106 classifies PDD's as pedestrians and that the robots have to operate according to all pedestrian regulations of the Vehicle Code. Scott stated that there are a few exceptions, PDDs must yield the right-of-way to pedestrians or cyclists

and the PDDs are permitted to operate in the roadway in specific conditions, and the PDDs can operate up to 25 mph when operating in the roadway.

Scott informed the Committee that the comment period has ended and that he participated in a webinar on PDD's. Scott stated that the main points of the webinar were that PDD's are still a new technology and there is very little usage of PDD's nationwide. Scott stated that essentially every municipality in the State will have the opportunity to approve or deny the usage of PDD's within their municipal boundaries. Scott stated that one question he asked was if there is the ability for PennDOT to collect a fee from PDD operators to use towards infrastructure maintenance or improvements. Scott stated that there is no process for municipalities to charge a fee for usage.

Mark Murawski stated that he saw the SEDA-COG comments regarding PDD's and suggested that the MPO jointly support the comments that SEDA-COG submitted. Commissioner Mirabito asked why the Act 106 was done without Governor Wolf's signature. Scott stated that he was unsure why the Governor's signature was not included. Commissioner Mirabito asked if Act 106 was a stand-alone bill or if there was other legislation included. Councilmember Banks stated that Act 106 appears to be a standalone bill.

Councilmember Banks asked if there was any information on what happens if a PennDOT District approves the use of PDD's but a municipality denies the use on the State routes within the municipality. Scott stated that from his understanding it is up to the municipality to approve or deny and then PennDOT authorizes the use. Scott stated that there is a PennDOT documentation process which tracks which roadways/routes will use the PDDs.

Commissioner Mirabito inquired if State legislation allows a municipality to limit certain weight/size trucks on the roads within the municipality, and if that process could be used for PDD's. Chairperson Tosca stated that the posted roads with weight restrictions is one way a municipality can control usage, however, a municipality cannot just restrict usage unilaterally. Mark Murawski asked if a municipality decided not to approve the use of PDDs would, the municipality be required to list the criteria stating "why" the municipality is denying the usage. Chairperson Tosca stated that the legislation is so new that PennDOT is still receiving guidance on Act 106.

Chris King reached out to Mark Kopko (Special Advisor to the Secretary of Transformational Technologies) after the meeting. Mark Kopko's comments are included below for ACT 106 clarification purposes:

Under the law, a municipality has no authority to approve or deny a PDD. The only authority a municipality has is to prohibit operations on a roadway, shoulder or berm of a roadway, or pedestrian area (e.g. sidewalk) that they deem operations will pose a hazard. This can only be done through the passage of an ordinance or resolution. However, per the law, a municipality must have a consultation with the authorized PDD entity first. There is no requirement that a PDD entity and local must agree – a conversation just has to happen. It is worth pointing out the term "authorized." A local cannot take a preemptive approach to pass an ordinance, but has to first wait until a PDD is authorized by PennDOT. Per the law, an authorized entity must inform a municipality of their intent to operate at least 30 days in advance.

OTHER BUSINESS / PUBLIC COMMENT

Chairperson Tosca asked if there was any other business or any other public comments. Mark Murawski suggested that Jeff Stover and Richard Howell can give an update on SEDA-COG Joint Rail Authority and the Williamsport Regional Airport.

Jeff Stover stated that rail traffic was stable throughout 2020 however it did go down approximately 10%. Jeff stated that they are seeing some Marcellus activity and that First Quality has been picking up production due to demand for paper products. Jeff stated that the rail traffic was down approximately 600 cars however all things consider with COVID-19 the rail traffic is stable. Mark asked if there are any infrastructure projects that the MPO should be aware of coming up. Jeff stated that there were some rail replacements in the Muncy area, and a project to raise the rail bridge on Route 220 which is still in development. Richard Howell was not available to give an update on the Williamsport Regional Airport.

Chairperson Tosca asked if there was any other business or any other public comments. Hearing none, Chairperson Tosca called for a motion to adjourn.

ADJOURN

Commissioner Mirabito offered a motion to adjourn, Carey Mullins seconded. The motion to adjourn unanimously passed and the meeting adjourned at 1:48 P.M.
